Registration is now open through July 28, 2025, for the Currituck Tackle Football. Anyone registering for these teams must have reached the age of 7 prior to September 1, 2025 and must not have reached the age of 13 prior to September 1, 2025.

Anyone on a School Football team is ineligible for play.

There will be a registration fee of \$40.00. This money will be used to provide insurance and help recover a small portion of the cost to supply and maintain the needed equipment.

All players must provide an eligible birth certificate to participate.
