The scope of work for this project will include **the construction of the Currituck County Corolla Multi-Use Path Greenway Phase V** located in Corolla, North Carolina

In lieu of cash or a certified check, the Bidder may submit a bid bond in the form prescribed in G.S. 143-129 as amended by Chapter 1104 of the Public Laws of 1951. Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts. General Contractor shall be a qualified and properly registered Highway Contractor.

There **WILL** be a mandatory pre-bid conference for all past and present bidders for this project on **Wednesday, January 30th, 2019** at 11:00 am at the Currituck County Satellite Office located at 1123 Ocean Trail, Corolla NC 27927. All bidders **must** attend including those that attended the prior pre-bid conference held, January 8th, 2019.

The Owner reserves the right to waive any informalities or to reject any or all bids, and to award contract which, in which the opinion of the Owner, appear to be in its best interest.
