

January 6, 2020 Minutes – Regular Meeting of the Board of Commissioners

WORK SESSION

1. 5:00 PM Minimum Lot Sizes, As Built Survey Amendment, Moyock Sewer Update, Sand Fencing

The Currituck County Board of Commissioners met in a Work Session in the Conference Room of the Historic Courthouse and discussed the following:

County Manager, Ben Stikeleather, recalled recent Strategic Planning Sessions where Commissioners discussed ways to slow growth in the Moyock area. Planning and Community Development Director Laurie LoCicero, and Assistant Planning Director Donna Voliva, presented options for Board consideration and suggested text amendments to the Unified Development Ordinance to require a larger minimum lot size or to reduce density requirements. After explanations of each, staff said addressing density is preferred, as these modifications can provide for more open space and natural areas, with less sprawl as would occur with larger minimum lot sizes. Commissioners asked staff to develop a scenario for each method, and a combination plan, to demonstate what implementation would look like from the North Carolina/Virginia line in Moyock south to the Coinjock bridge.

Recent driveway installations that were considerably wider than the widths designated on subdivision plats resulted in a directive requiring county building inspectors to review plats to determine lot coverage as part of the inspection process. Ms. LoCicero presented challenges with the practice and recommended a change to the Unified Development Ordinance to require post construction, as-built surveys for all new construction going forward. Commissioners agreed to move forward and implement as-built survey requirements for lots up to 40,000 square feet.

Mr. Stikeleather provided a status update on the Moyock Wastewater Plant expansion. He said completion will likely be delayed until May, 2021, and presented bringing the Moyock Commons sewer plant back online as an option so sewer could be available for business hookups. He reported an initial, one-time cost of \$180,000 with an annual operating cost of \$155,000. Mr. Stikeleather presented the background info for further discussion at the upcoming Board retreat.

Mr. Stikeleather asked the Board if they would consider instituting a sand fencing grant program, similar to the beach planting grant, in the continued effort to help with dune preservation. After discussion, Commissioners agreed to move forward with a program and asked staff to work out the details for review at the upcoming Board retreat.

Mr. Stikeleather reported Frank Bernard, who owns a camper and recreational vehicle sales business next door to the Currituck County Welcome Center, Moyock, asked if the county would be interested in selling him a strip of property behind the Welcome Center. Commissioners noted the land is already being used for his business, and Mr. Stikeleather recommended leasing the property to Mr. Bernard as opposed to selling. The Board agreed and Mr. Stikeleather said he would discuss a lease with Mr. Bernard.

There was no further discussion and the work session concluded at 5:50 PM.

PUBLIC COMMENT

Samantha Williamson, a resident of Brady Landing Airpark in Maple, described receiving a notice from her subdivision's homeowner association (HOA) regarding a complaint they received about her running a home day-care business from her residence. Resulting litigation ultimately caused her to have to shut down the business. She said the HOA argued her business violates language in the county code and that it jeopardized the Through the Fence easement agreement in place that provides direct airport access for residents. She asked the Board to intervene on her behalf. Ms. Williamson responded to Commissioner questions and clarified she received HOA approval to operate the daycare prior to purchasing her home. Commissioner Beaumont said he was familiar with the case and that several misrepresentations were made by the HOA pertaining to county regulations during their court proceeding to seek an injunction against Ms. Williamson.

Cathi Feiock spoke on behalf of Ms. Williamson and said she and her husband sold their house to Ms. Williamson, which is located next door to their current residence. She also reported no issues were raised by the HOA when she discussed Ms. Williamson's intent to operate a home based daycare at the residence. She described how the HOA went immediately to a civil suit, skipping mediation, and asked the Board to assist in demonstrating that the day care business does not jeopardize the Through the Fence easement agreement.

County Attorney, Ike McRee, clarified the Through the Fence agreement is only relevant to the Federal Aviation Administration and aeronautical business. Commissioner Beaumont said he has witnessed individuals in the airpark violate the terms of the easement. Mr. McRee confirmed use of the gate for other than aircraft is a definitive violation, and terms provide for consequences or revocation should the county choose to do so.

COMMISSIONER'S REPORT

Chairman White recognized Commissioner Payment's absence due to the loss of his brother-inlaw and offered his condolences. He remembered former Commissioner Marion Gilbert, who recently passed, and honored her service to the county and her work with Currituck Kids. A review of county projects of the past year and those upcoming were presented, and he discussed the recent Strategic Planning Sessions where Commissioners participated in visioning and planning exercises. He noted the upcoming Budget sessions and work with the Board of Education on new school construction. The Chairman said he looks forward to working with fellow Board members in 2020.

Commissioner Mary Etheridge discussed the Womens Suffrage Resolution on the agenda celebrating the 100th anniversary of the passage of the nineteenth amendment, which she said passed by only one vote. She said voting does change the course of history and spoke of the importance of free elections and to cherish the privilege. She encouraged all to vote in the March 3, 2020 primary election.

Commissioner McCord also acknowledged former Commissioner, Marion Gilbert, and her work in the community and with Currituck Kids. He remembered other members of the Currituck County community who were lost in 2019. He wished everyone a Happy New Year and looks forward to the good things to come in 2020.

J. Owen Etheridge discussed challenges with social media and said it is the one main difference from when he initially served in 1994. He discussed the authority granted to the Board by the state and said he looks at challenges and criticisms from the public as an opportunity. He talked of his long history of service and said he will continue to work to help people in the county. He wished everyone a Happy 2020.

Commissioner Jarvis said she is both thankful and grateful for the opportunity to serve as Commissioner. She looks forward to serving on the Juvenile Crime Prevention Council after attending her first meeting in December. Ms. Jarvis said she, along with Planning Director, Laurie LoCicero, and County Attorney, Ike McRee, recently presented at a Chamber of Commerce leadership class on county government. She discussed the upcoming Citizens Academy and encouraged everyone to read about it in the FOCUS or on the county website. She looks forward to another year of service.

COUNTY MANAGER'S REPORT

County Manager, Ben Stikeleather, encouraged those interested in the Citizens Academy to contact the county's Public Information office for information. He said two sessions are planned, a spring session on the mainland and a fall session in Corolla. He announced the success of the Travel & Tourism Department's new event assistance grant program and said nine applications have been received. He announced the Department of Social Services assisted over 300 children through the Operation Santa Clause program this holiday season. Mr. Stikeleather offered his thanks to the Board for their show of support and concern during his son's illness.

ADMINISTRATIVE REPORTS

A. Recognition and Presentation of Advanced Law Enforcement Certificates and Sheriff Department Employee Recognition

Currituck County Sheriff, Matt Beickert, recognized members of the Currituck County Sheriff's Department who achieved the North Carolina Advanced Law Enforcement Certifications. Sheriff Beickert read the certificate and recipients were presented with a framed copy. Those honored were Deputy Neel Smith, Deputy Patrick Morgan, Deputy Wesley Alcott, Sergeant William Davenport and Sergeant Kevin McCord, who also serves as a County Commissioner.

Sheriff Beickert recognized Swaney Dudley on her recent promotion to Sergeant of the Detective Division. Sheriff Beickert thanked all of the officers, the Board of Commissioners and citizens of the county.

Commissioner J. Owen Etheridge took a moment to announce Law Enforcement Appreciation Day is Thursday, January 9, 2020, and asked citizens to be sure to thank law enforcement officers for their service.

A. Resolution Celebrating the 100th Anniversary of the Passage of the Nineteenth Amendment to the Constitution-League of Women Voters

Commissioner Jarvis discussed today's role of women in the country and the wisdom of those who voted to allow women the right to vote 100 years ago. Commissioner Jarvis read the Resolution Celebrating the 100th Anniversary of the Passage of the Nineteenth Amendment to the Constitution of the United States for Board consideration. Commissioner Mary Etheridge seconded and the Resolution was adopted unanimously.

Resolution of the Board of **Commissioners Celebrating the League** 100th and of Women **Voters** the Anniversary of **Passage** of the Nineteenth Amendment to the

Constitution

WHEREAS, an organized movement to enfranchise women began in July, 1848, at a convention in Seneca Falls, New York; and

WHEREAS, through the efforts of brave and courageous women referred to as suffragists who sacrificed family, their personal life and their financial resources for over seventy years to gain equal rights for women, especially the right to vote; and

WHEREAS, women and men, black and white, supported the woman's suffrage movement for women to gain the constitutional right of having a voice in making the laws that govern them; and

WHEREAS, the woman's suffrage movement led to the passage of the 19th Amendment to the Constitution of the United States in 1919, with ratification by the states by the summer of 1920; and

WHEREAS, the National Woman's Suffrage Association dissolved in 1920 to create the League of Women Voters of the US to register voters and educate all voters; and

WHEREAS, the League of Women Voters of North Carolina was launched on October 7, 1920, on the steps of the Guilford County Courthouse by Gertrude Weil, a politically active and tireless young woman from Goldsboro, North Carolina; and

WHEREAS, more than 120,000 women were registered to vote in North Carolina by 1920; and

WHEREAS, women today constitute a majority vote in our state and the US and are running for office in higher numbers and more active in the election process than ever before in history.

THEREFORE, BE IT RESOLVED, that the 100th anniversary of women gaining the right to vote and the founding of the League of Women Voters in the United States and in North Carolina is recognized for the impact these historic accomplishments have on citizen engagement and the civic life of the community, the state and the nation.

B. Resolution Authorizing the Purchase of Kamstrup Meters from Fortiline, Inc. Through Sole Source Purchase

County Attorney, Ike McRee, reviewed the Sole Source Purchase Resolution and the bid exception that allows a local government to purchase equipment for standardization and compatibility purposes. Staff recommended approval the Sole Source Resolution was approved unanimously by consensus.

RESOLUTION AUTHORIZING THE PURCHASE OF KAMSTRUP METERS FROM FORTILINE, INC. THROUGH SOLE SOURCE PURCHASE PURSUANT TO N.C. GEN. STAT. §143-129(e)(6)

WHEREAS, N.C. Gen. Stat. §143-129(e)(6) authorizes a unit of local government to purchase apparatus, supplies, materials or equipment when standardization or compatibility is an overriding consideration; and

WHEREAS, proper functioning of the county's Mainland Water System requires replacement meters compatible with existing systems equipment and;

WHEREAS, as the sole and exclusive distributor of Kamstrup AMR and AMI meters in the State of North Carolina, Fortiline, Inc. is the only entity capable of providing the county with meters compatible with current Mainland Water System equipment and operational systems, and

WHEREAS, Mainland Water System has been using Fortiline, Inc. to construct, develop and upgrade its system; and

WHEREAS, Mainland Water Department needs replacement meters and Fortiline, Inc. is the sole supplier of compatible meters; and

WHEREAS, Fortiline, Inc. is supplying Mainland Water Department with $386\,5/8x3/4$ FlowIQ 2100 Kamstrup meters at a cost of \$160/meter; and

WHEREAS, the total cost for the Mainland Water Department meter purchase is \$65,928.80.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for Currituck County, North Carolina as follows:

Section 1. The County of Currituck is authorized to enter into a contract in the amount of \$65,928.80 with Fortiline, Inc. for the sole source purchase of FlowIQ 2100 Kamstrup meters in accordance with the sole source provision requirements set forth by N.C. Gen. Stat. §143-129(e)(6). Further, the County Manager is authorized to execute the agreement with Fortiline, Inc. for the acquisition apparatus, materials, and equipment acquisition described in this resolution and the proposed contract.

Section 2. This resolution shall be effective upon its adoption.

5. Resolution Opposing Reclassification of Jurisdictional Waters

RESOLUTION OF THE CURRITUCK COUNTY BOARD OF COMMISSIONERS OPPOSING RECLASSIFICATION OF JURISDICTIONAL WATERS

WHEREAS, in January of 2019, the NC Marine Fisheries Commission (MFC) and the NC Wildlife Resources Commission (WRC) formed a joint committee for the purpose of determining

boundaries defining inland and coastal waters; and

WHEREAS, the joint committee had its last meeting in May of 2019, after having disagreements between the agencies on the "salinity value" to determine boundaries; and

WHEREAS, in August of 2019, the WRC business meeting was held with little direct notice to the MFC or to the NC Department of Environmental Quality (NCDEQ). At this meeting the WRC decided to move forward with the proposed boundaries based on the arbitrary "2.6 ppt salinity value"; and

WHEREAS, in 2017 the MFC conducted a review of rules pertaining to delineation (15A NCAC 03Q .0200 et seq) and determined there was no basis to adjust jurisdictional boundaries; and

WHEREAS, the proposed Reclassification of Jurisdictional Waters would be a loss of approximately 144,984 square acres or 226.5 sq. miles of coastal and commercial fishing waters. Thus, creating even more confusion and regulations to the already over regulated NC commercial fishing industry; and

WHEREAS, the MFC would be required by law, to perform a comprehensive financial analysis to modify jurisdictional boundaries, which would include a review of all existing rules and a detailed mapping effort expected to take over a year to complete with added costs to the taxpayers of North Carolina; and

WHEREAS, the financial impact as proposed would exceed \$1,000,000.00 for sustainable economic impact as prescribed in the NC Administrative Procedure Act; and

WHEREAS, fisheries management plans of important commercial and recreational species under MFC authority follow a criterion initially to establish coastal and joint waters but not inland waters. Thus, a complete review of all MFC rules would have to be completed at NC taxpayer expense.

THEREFORE, BE IT RESOLVED, that the Currituck County Board of Commissioners strongly opposes the Reclassification of Jurisdictional Waters as prescribed by the NC Wildlife Resources Commission. Under such research we have not found where a Salinity Value is a determination of boundary lines between coastal and inland waterways.

WHEREAS, radon is the second leading cause of lung cancer in the U.S. and is the leading cause of lung cancer in non-smokers; and

WHEREAS, the National Academy of Sciences estimates that up to 21,000 lung cancer deaths occur in the United States each year; and

WHEREAS, one in 15 homes across the U.S. have elevated radon levels; and

WHEREAS, any home may have elevated levels of radon, even if neighboring homes do not, and living in a home with an average radon level of 4 picocuries per liter of air poses a similar risk of developing lung cancer as smoking half a pack of cigarettes a day; and

WHEREAS, testing for radon is simple and inexpensive and radon problems can be fixed; and

WHEREAS, the U.S. Surgeon General, the U.S. Environmental Protection Agency, the NC Department of Health and Human Services' NC Radon Program, the North Carolina Advisory Committee on Cancer Coordination and Control, and the Board of Commissioners support efforts to encourage homeowners to test for radon and have elevated levels of radon reduced; and

WHEREAS, many residents in Currituck County don't know about radon, yet need to know for the safety and health of their families, and a proclamation of National Radon Action Month is an opportunity to educate individuals on the available measures to reduce radon.

NOW, THEREFORE, the Currituck County Board of Commissioners does hereby proclaim **JANUARY**, **2020**, as **National Radon Action Month** in Currituck County, North Carolina.

The Constitution of the United States of America, Amendment XIX Women's Suffrage

WORK SESSION

1. 5:00 PM Commissioner Service on Advisory Boards

The Currituck County Board of Commissioners met at 5:00 PM in the Conference Room of the Historic Courthouse for a work session to establish Commissioner's service on local and regional advisory Boards. County Manager, Ben Stikeleather, reviewed the purpose and goals of each Board after which two changes were made to existing appointments, effective January, 2020. Commissioner J. Owen Etheridge replaced Commissioner Beaumont on the Albemarle Commission and Commissioner Jarvis replaced Commissioner Mary Etheridge on the Juvenile Crime Prevention Council.

The County Manager reviewed additional items with Commissioners:

- Mr. Stikeleather will attend a meeting with the Board of Education to discuss sites for a new elementary school in Moyock and school district boundaries, which are necessary for determining whether the county's adequate public facilities ordinance can be met based on projected student counts for two large subdivisions to be built in Moyock.
- The county's pay study has commenced.
- As a follow up to an earlier work session to address damages at the Ecoplexus solar facility in Grandy due to Hurricane Dorian, Mr. Stikeleather reported that Ecoplexus has offered to pay the fee for an independent engineering review of the facility site plans. Mr. Stikeleather said the county had been quoted a cost of \$1,500, and Commissioners directed staff to move forward with the review.
- Discussion related to a request by developer, Sam Miller, who wants the county to be responsible for the cost to install a six inch waterline for a subdivision he is building in Moyock. Mr. Stikeleather explained the waterline at the site is a two inch line but was erroneously labeled as a six inch line in the County's GIS system. Commissioners considered the request and, after discussion, declined the request.

There was no further business and the work session concluded at 5:48 PM.

Denise Fallon, JP Knapp Early College Principal, shared information on the school and their accomplishments. She noted a two point jump in SAT scores and the school's earning an A grade from the state for its fifth consecutive year. She discussed the upcoming student recruitment period and parent information meetings. Ms. Fallon responded to Board

questions and highlighted student internship opportunities and programs, and processes for acceptance into the Early College.

Nathan Morales of Moyock discussed drainage issues that have developed on his property since construction began on the neighboring Windswept Pines subdivision in Moyock. He believes the rerouting of ditches and construction of retention ponds in Windswept Pines are causing septic and stormwater flooding issues on his property. He described inadequate downstream culvert piping that is not able handle the stormwater drainage from the subdivision. He asked the Board to require a downstream water analysis for new developments and to improve downstream situations.

Commissioners discussed Mr. Morales' concerns, and he provided additional detail on culvert and ditching issues. Challenges for downstream improvements, such as accessing privately owned culverts and ditches for clearing were discussed and Commissioner Beaumont suggested stormwater plans submitted for development that show a change in outflow should require a downstream analysis for approval.

No others were signed up nor wished to speak and the Public Comment period was closed.

COMMISSIONER'S REPORT

Commissioner Jarvis reported on the Trillium Regional Advisory meeting recently attended, which included a brief on vaping. She said the information and statistics presented were daunting, and she encouraged parents to talk with their teens about the dangers of vaping. She reported Medicaid transformation has been suspended because the state has yet to pass a budget. Commissioner Jarvis had also attended the Area 5 Soil and Water Conservation District Meeting and thanked the Soil & Water Board for their work.

Commissioner J. Owen Etheridge congratulated Currituck County schools athletes on a successful fall season. He wished everyone a Merry Christmas and discussed the meaning of the season. He reported on the success of this year's Curri-shuck event at Sanctuary Vineyards.

Commissioner McCord also congratulated the county's school athletes. He encouraged citizens to support the Department of Social Services by donating to their Operation Santa Clause program. He announced the County's upcoming Christmas Parade and Tree Lighting at Cooperative Extension.

Commissioner Beaumont encouraged Corolla and Knotts Island residents interested in representing their service district as a member of the Fire and Emergency Medical Services Advisory Board to submit a Statement of Interest to the county. He attended the Veterans Day celebration at Veterans' Park and thanked participants, including the Boy Scouts of America and students from Kelly's Dance Studio, who performed. He discussed the county's Veterans registration and encouraged veterans residing in the county to sign up.

Commissioner Mary Etheridge congratulated Ashley Basnight who will be featured on a television show called "Makin' It". She encouraged everyone to watch the show that was airing later, as Ms. Basnight is a Currituck County native and the owner of Handmade Haven, the business that will be featured.

Commissioner Payment wished everyone a safe and Merry Christmas and thanked Commissioners for a productive year.

Chairman White also reported his attendance at the recent Area 5 Soil & Water meeting.

COUNTY MANAGER'S REPORT

County Manager, Ben Stikeleather, reported site clearing has begun for construction at the new public safety building, which will be located next to the College of the Albemarle's Regional Aviation Technical Training Center.

The proposed text amendment, submitted by Fenton Eure of Nutrien Ag Solutions, revises Chapter 4 of the Unified Development Ordinance (UDO) to allow distribution of agronomic products under the Agricultural Support and Services (Not Directly Related) use category. Agronomic products include, but are not limited to, seeds, fertilizer, and soil and plant amendments. The draft language revises a change to the specific standards for Agricultural Support and Services, and the definitions related to the request.

Background

The applicant is currently operating an agronomic product distribution business from a facility located at 119 Central Ln. in Shawboro. They have a need to erect an additional building on site in order to have designated buildings for each type of product. The new building would be located on what is now staging and vehicular use area and, therefore, would not constitute an expansion of the use.

The UDO currently includes distribution hubs for agricultural products as a permissible use in the Agricultural, General Business, Limited Business, Heavy Industrial and Light Industrial zoning districts. Distribution Hub for Agricultural Products is defined as:

A place where farmers can deliver agricultural products for pick-up by consumers or wholesalers, but not including a central place operated by a farm co-op where farmers can deliver products for pick-up by consumers.

The proposed amendment would allow distribution of agronomic products under the same use category as agricultural products. It would also be allowed in the same zoning districts as a distribution hub for agricultural products. This is a necessary and important support service for the County's agricultural industry.

The current ordinance language requires that distribution hubs have direct access from a major arterial or collector street. The proposed amendment will add direct access to a railway as an additional option. The specific standards for the use will be updated to include opaque screening from off-site views for new uses, and for existing uses when the use area is expanded by more than 50 percent.

Text Amendment Review Standards

The advisability of amending the text of the UDO is a matter committed to the legislative discretion of the Board of Commissioners and is not controlled by any one factor. In determining whether to adopt or deny the proposed text amendment, the Board of Commissioners <u>may</u> weigh the relevance of and consider whether and the extent to which the proposed text amendment:

- 1. Is consistent with the goals, objectives, and policies of the Land Use Plan and other applicable county-adopted plans;
 - a. The proposed text amendment is consistent with the following 2006 Land Use Plan Policies:
 - POLICY ID5: WAREHOUSING, STORAGE AND DISTRIBUTION facilities shall have access to thoroughfares of adequate traffic carrying capacity, and shall be appropriately designed and/or visually buffered according to the visibility of their location.
 - POLICY ED1: NEW AND EXPANDING INDUSTRIES AND BUSINESSES should be especially encouraged that: 1) diversify the local economy, 2) train and utilize a more highly skilled labor force, and (3) are compatible with the environmental quality and natural amenity based economy of Currituck County.
- 2. Is not in conflict with any provision of this Ordinance or the County Code of Ordinances;
 - a. The text amendment request is consistent with the provisions of the UDO and the County Code of Ordinances.
- 3. Is required by changed conditions;
- 4. Addresses a demonstrated community need;
 - a. Distribution of agronomic products is a necessary service for supporting the agricultural industry in Currituck County.
- 5. Is consistent with the purpose and intent of the zoning districts in this Ordinance, or would improve compatibility among uses and ensure efficient development within the county;
 - a. The text amendment request is consistent with the purpose and intent of the zoning districts. The Agriculture zoning district currently allows several Agriculture related uses that might otherwise be considered commercial or industrial uses. The addition of agronomic product distribution to the ordinance is vital to continued agricultural success in Currituck. Similar uses are allowed in the Limited and General Business, as well as the Light and Heavy Industrial, zoning districts.
- 6. Would result in a logical and orderly development pattern; and
 - a. The text amendment request will result in a logical and orderly development pattern and specific standards are provided to mitigate impacts on surrounding properties.
- 7. Would not result in significantly adverse impacts on the natural environment, including but not limited to water, air, noise, stormwater management, wildlife, vegetation, wetlands, and the natural functioning of the environment.

Staff Recommendation

Staff recommends approval of this request subject to the proposed staff additions and the staff suggested Statement of Consistency and Reasonableness listed in the staff report.

Planning Board Recommendation

Planning Board recommends approval of the request as presented.

Nutrien Ag Solutions requests an amendment to the Unified Development Ordinance, Chapter 4 Use Standards, to allow distribution of agronomic products under the *Agricultural Support Services (Not Directly Related)* use category.

BE IT ORDAINED by the Board of Commissioners of the County of Currituck, North Carolina that the Unified Development Ordinance of the County of Currituck be amended as follows:

Item 1: That Chapter 4 is amended by deleting the following strikethrough language and adding the bold and underlined language.

That Chapter 10 is amended by deleting the following strikethrough language and adding the bold and underlined language.

DISTRIBUTION HUB FOR AGRONOMIC PRODUCTS

A place where agronomic products are available for pick up or delivery. Agronomic products include but are not limited to seeds, fertilizer, and soil and plant amendments.

Item 2: Staff suggested Statement of Consistency and Reasonableness:

Land Use Plan Consistency

The UDO requires that the Board of Commissioners adopt a statement of consistency and reasonableness that describes whether the decision on the amendment is consistent with county adopted plans that are applicable and why the decision is reasonable and in the public interest.

The requested text amendment is consistent with the goals, objectives and policies of the 2006 Land Use Plan including:

<u>POLICY ID5</u>: WAREHOUSING, STORAGE AND DISTRIBUTION facilities shall have access to thoroughfares of adequate traffic carrying capacity, and shall be appropriately designed and/or visually buffered according to the visibility of their location.

<u>POLICY ED1</u>: NEW AND EXPANDING INDUSTRIES AND BUSINESSES should be especially encouraged that: 1) diversify the local economy, 2) train and utilize a more highly skilled labor force, and (3) are compatible with the environmental quality and natural amenity based economy of Currituck County.

The request is reasonable and in the public interest because:

1. It is an existing and necessary support service for agriculture.

Item 3: The provisions of this Ordinance are severable and if any of its provisions or any sentence, clause, or paragraph or the application thereof to any person or circumstance shall be held unconstitutional or violative of the Laws of the State of North Carolina by any court of competent jurisdiction, the decision of such court shall not affect or impair any of the remaining provisions which can be given effect without the invalid provision or application.

Item 4: This ordinance amendment shall be in effect from and after the _____ day of _____, 2019.

Prior to review, disclosures were presented by Commissioner J. Owen Etheridge, who is a patron of Nutrien Ag Solutions, and Commissioner Mary Etheridge, who said her family owns the property adjacent to the company. County Attorney, Ike McRee, said he sees no conflict of interest to warrant a recusal from voting for either, based on state statute and the information presented by the Commissioners.

Laurie LoCicero, Planning and Community Development Director, reviewed the application for Commissioners which would allow for a new building to be constructed on the site. She read the proposed language that specifically addresses agronomic products. Both staff and Planning Board recommend approval. It was noted the text amendment would apply county-wide and supporting policies were presented.

Applicant and Nutrien Ag Solutions Location Manager, Fenton Eure, said the company has been operating at the location for many years, prior to 1965, and are looking to upgrade to make the area more user and community friendly. He described the facility layout using an overhead slide of the current site, and said they propose to replace individual containers currently used at the site with a warehouse facility. He described the issues realized during the process related to general business zoning and the resulting need for the amendment.

Chairman White opened the Public Hearing. No one was signed up nor wished to speak and the Public Hearing was closed.

Commissioner Beaumont moved to approve PB 19-26 because the request is consistent with the goals, objectives and policies of the 2006 Land Use Plan, including Policy ID5-Warehousing, storage and distribution facilities shall have access to thoroughfares of

adequate traffic carrying capacity and shall be appropriately designed and/or buffered according to the visibility of their location. Policy ED1-New and Expanding industries and businesses should be especially encouraged that diversify the local economy, train and utilize a more highly skilled labor force, and are compatible with the environmental quality and natural amenity-based economy of Currituck County. The request is reasonable and in the public interest because it is already existing and a necessary support service for agriculture.

Commissioner Mary Etheridge seconded the motion. The motion carried.

A. PB 19-21 Island Development Text Amendment: Guy Lunsford is requesting a text amendment to allow development on islands accessible only by boat.

Background

The purpose of the text amendment is to allow development on islands with boat only access. If approved, the text amendment will apply countywide and there are 21 privately owned islands off of Currituck Mainland. While the text amendment will apply countywide, Mr. Lunsford is particularly interested in developing the five 10+ acre lots on Long Point, an island in the Coinjock Bay.

In 2005, Wayne Meyers submitted a similar text amendment that the BOC eventually denied in 2008 for development of the same island. The primary concerns for denial of the text amendment at that time were citizen health and safety and for providing county services. Since this text amendment request is so significant in regards to citizen health and safety, it was reviewed by TRC. In reviewing the current TRC comments, you will find some of the same concerns with previous text amendment request in this text amendment request.

In 2006 The Currituck Island Company LLC purchased the property. Mr. Lunsford was the managing member of that LLC. On January 12, 2017 the Currituck Island Company LLC subdivided the single lot island into five 10+ acre lots. By North Caroline General Statute, properties being divided into lots greater than 10 acres are exempt from subdivision regulations. The 10+ acre lots are not exempt from zoning standards or NC Building code. On March 28, 2017, the property transferred from The Currituck Island Company LLC to Mr. Lunsford.

Text Amendment Review Standards

The advisability of amending the text of the UDO is a matter committed to the legislative discretion of the Board of Commissioners and is not controlled by any one factor. In determining whether to adopt or deny the proposed text amendment, the Board of Commissioners may weigh the relevance of and consider whether and the extent to which the proposed text amendment:

- 1. Is consistent with the goals, objectives, and policies of the Land Use Plan and other applicable county-adopted plans;
 - Policy PP2 of the LUP states that adequate public facilities, sufficient to support associated growth and development must be available. Firefighting, emergency medical services, etc. will not be available to the island based on TRC comments.
- 2. Is not in conflict with any provision of this Ordinance or the County Code of Ordinances;
 - One of the purposes of the UDO is to facilitate the adequate provision of transportation, utilities, parks, recreation, emergency services, and other public facilities. (Section 1.3.J) This request is in direct conflict with the purpose of the UDO since emergency services will not be available to serve an island with boat only access. Adequate public facilities are not available to serve an island with boat only access. (Reference TRC Comments)
- 3. Is required by changed conditions;
 - Staff is unaware of changed conditions since the previous text amendment request in 2005.
- 4. Addresses a demonstrated community need;
- 5. Is consistent with the purpose and intent of the zoning districts in this Ordinance, or would improve compatibility among uses and ensure efficient development within the county;
- 6. Would result in a logical and orderly development pattern; and
 - Allowing development on an island with boat only access where firefighting and emergency medical services is not available is neither logical or orderly.
- 7. Would not result in significantly adverse impacts on the natural environment, including but not limited to water, air, noise, stormwater management, wildlife, vegetation, wetlands, and the natural functioning of the environment.

Technical Review Committee Recommendation

TRC recommends denial of this request subject to the review standards noted above and the staff suggested Statement of Consistency and Reasonableness listed in the attached staff report.

Planning Board Recommendation

Planning Board recommends denial of this request subject to the review standards noted above and the staff suggested Statement of Consistency and Reasonableness listed in the attached staff report.

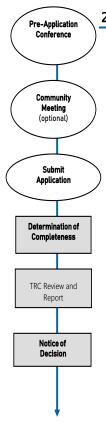


Gregory E. Willis, on behalf of his client, Guy Lunsford, request an amendment to the Unified Development Ordinance, Chapter 2 Administration, Chapter 3 Zoning Districts, and Chapter 10 Definitions and Measurement, to allow single-family dwellings to be built on islands accessible only by boat.

BE IT ORDAINED by the Board of Commissioners of the County of Currituck, North Carolina that the Unified Development Ordinance of the County of Currituck be amended as follows:

Highlighted items are based on direction from the Board of Commissioners at its November 18, 2019 work session.

Item 1: That Chapter 2 is amended by adding Section 2.4.19 Island Development:



Zoning

Compliance Permit – Island

Development

2.4.19 Zoning Compliance Permit - Island Development

Purpose

The purpose of a zoning compliance permit for island development is to ensure no development occurs unless the development complies with the requirements of this ordinance.

A. Applicability

A zoning compliance permit for island development is required before issuance of a building permit, any change in use, or commencement of activity that does not require issuance of a building permit.

B. Zoning Compliance Permit - Island Development Procedure

(1) Pre-Application Conference

Applicable (see Section 2.3.2).

(2) Community Meeting

Not applicable

(3) Application Submittal and Acceptance

Applicable (see Section 2.3.4). Prior to the issuance of a zoning compliance permit for island development, verification must be submitted by the applicant that the lot will be served by either a state-approved package plat, public sewer facility, or a waste treatment system complying with the requirements of the Albemarle Regional Health Services, where applicable.

(4) Staff Review and Action

Applicable (see Section 2.3.5). The Planning Director shall review and decide the application in accordance with Section 2.3.5.D, Applications Subject to Decisions by Planning Director or Technical Review Committee, and Section 2.4.9.D, Zoning Compliance Review Standards.

(5) Public Hearing Scheduling and Public Notification

Not Applicable.

(6) Public Hearing Procedures

Not Applicable.

(7) Advisory Body Review and Recommendation

Not applicable.

(8) Decision-Making Body Review and Decision

Not applicable.

c. Zoning Compliance - Review Standards

A zoning compliance permit for island development shall be approved upon finding that the applicant demonstrates the proposed development complies with all applicable standards in this Ordinance, the County Code of Ordinances, and the following:

- (1) The zoning compliance permit for island development contains a clearly visible disclaimer that states "County services including, but not limited to transportation, emergency services, law enforcement, and fire and rescue are not available at this location."
- (2) The application provides an appropriate location on the mainland, approved by the Planning Director, for staging of construction for new development on the island. The mainland location must be secured either through ownership or a written agreement provided to the Planning Director and shall be located in an appropriate zoning district.
- (3) No more than one single-family dwelling shall be constructed on an island. Accessory dwelling units are prohibited.
- (4) The single-family dwelling shall not exceed 4,000 sf.
- The single-family dwelling unit must have an approved NFPA 13D sprinkler system installed for fire protection as an alternate means of construction per section 105.1 of the 2018 edition of the North Carolina State Administrative Code. Since the dwelling unit will rely on a well for water, a storage tank, pump and emergency backup power source will be necessary to ensure an adequate means of water will be available to maintain the operation of the system per NFPA guidelines in the event of a fire. In the event that the system is disabled or is not maintained properly, the certificate of occupancy may be revoked until such time the system is placed in normal operation. The owner is to provide a certificate of inspection to the Fire Code Official once a year from a North Carolina licensed contractor certified to perform maintenance and inspection the system.

The applicant shall provide transportation for county staff or other public agency to access the island for official business (i.e. building inspector, zoning official, tax official, CAMA, environmental health, etc.).

(5) The application provides an appropriate location on the mainland with a boat launch, approved by the Planning Director, for parking of automobiles, boat trailers, etc.

The parking area must be:

Located in an appropriate zoning district;

Surfaced with asphalt, concrete, brick, crushed stone, pavers, aligned concrete strips, or an equivalent material. The materials shall be maintained in a smooth, well-graded condition;

Compliant with the parking standards in Table 5.1.3.C

Minimum Off-Street Parking Standards and Section 5.1.5 Dimensional Requirements; and,

Screened on all sides, except the water side, with a

Type D Opaque Buffer.

D. Effect of Development Agreement

Approval of a zoning compliance permit for island development authorizes an applicant to apply for a building permit, or to commence construction if the proposed development does not require a building permit.

E. Amendment of Development Approval

Applicable (See Section 2.3.14)

Expiration of Development Approval

Approval of a zoning compliance permit shall automatically expire if the development activity it authorizes is not commenced within six months after the date of approval.

Item 2: That Chapter 3 is amended by adding the bold and underlined language in Section 3.4.2.F:

Footnote [1] All lots shall maintain a minimum street frontage of 35' for cul-de-sac lots, except for lots on an island accessible only by boat.

Item 3: That Chapter 10, Section 10.3.3.B.6 is amended by adding the bold and underlined language in Section 3.4.2.F:

(6) Lot Access

- (a) No lot shall be established which does not All lots must abut a public or private right-of-way as permitted in these regulations unless the parent parcel has been planned for development in which the resulting lots are provided direct access to a public or private right-of-way across common property perpetually maintained for such purposes. Examples include townhome, condominium, or multi-family developments, and office park and shopping center developments.
- (b) Ever lot shall be configured so as to All lots must maintain at least 20 feet for ingress/egress of emergency service vehicles.
- (c) Lots on islands accessible only by boat are exempt from (a) and (b) above.

Item 4: That Chapter 10, Section 10.5 Definitions is amended by adding the bold and underlined language in Section 3.4.2.F:

ISLAND DEVELOPMENT

Development on an island accessible only by boat.

Item 5: Staff suggested Statement of Consistency and Reasonableness:

The requested zoning text amendment is not consistent with the 2006 Land Use Plan because:

- Policy PP2 of the LUP states that adequate public facilities, sufficient to support associated growth and development must be available. Firefighting, emergency medical services, etc. will not be available to the island based on TRC comments.
- Policy ES1 of the LUP states that new development shall be permitted to locate only in areas where suitable soils and adequate infrastructure is available. For reference, the soils map indicates that Long Point is unsuitable for a septic system and contains Currituck Mucky Peat (CU) and Conaby Muck (CB). These soils types are typical for islands off of the Currituck mainland.

The request is <u>not reasonable</u> and <u>not in the public interest</u> because:

 Adequate public services (firefighting, emergency medical services, law enforcement, or other county services, etc.) are not available to an island accessible only by boat.

Item 6: The provisions of this Ordinance are severable and if any of its provisions or any sentence, clause, or paragraph or the application thereof to any person or circumstance shall be held unconstitutional or violative of the Laws of the State of North Carolina by any court of competent jurisdiction, the decision of such court shall not affect or impair any of the remaining provisions which can be given effect without the invalid provision or application.

Item 7: This ordinance amendment shall be in effect from and after the _____ day of _ , 2019.

Tammy Glave, County Planner, presented the timeline and movement through the approval process for Island Development Text Amendment, PB 19-21. Ms. Glave noted the item was tabled at the November 4, 2019, Board of Commissioners meeting. A work session followed on November 18, 2019, and staff was directed to bring a text amendment forward for consideration that included the following language pertaining to island development:

- No more than one (1) single-family dwelling may be constructed, with no accessory dwellings permitted
- Single-family dwelling may not exceed 4,000 square feet
- Dwelling must be sprinklered and meet National Fire Protection Association guidelines
- Transportation for county staff or other public agencies is to be provided by the property owner
- Language pertaining to mainland locations for parking area and boat launch was deleted.

Ms. Glave said the Technical Review Committee and Planning Board recommend denial and reviewed policy noting the request's inconsistency with the 2006 Land Use Plan and the lack of access to county public services. It was noted a site evaluation performed by the county health department deemed one location on the island potentially suitable for septic.

After review, Commissioner Payment said he was unable to attend the November 18th work session due to illness and had not had an opportunity to review the information presented. He reported a lack of support for the amendment from his constituents, many who are duck hunters. He said the Lower Currituck Fire Chief does did not

support the amendment.

Commissioners clarified the provision requiring transportation for building inspectors or others to be provided by the builder or property owner, along with related insurance requirements and statutes pertaining to construction inspection timelines.

Commissioner Beaumont discussed property rights and said anyone who wishes to live on an island understands what they are getting into. He said the sprinkler requirement goes farther to address fire safety compared to what is required for other properties in the county. Commissioners Payment said he believes if the applicant didn't want to sell his property he wouldn't be making application and others who have come before the Board to ask for help have been denied. Chairman White commented that the applicant is a property owner and taxpayer, whether he is a resident or not, and Commissioner J. Owen Etheridge said other text amendment applicants may have had alternate uses for their land and questioned whether there is an alternative use for the island.

Potential ramifications to duck hunting were discussed and Chairman White asked Mr. Stikeleather, County Manager, to describe the different blinds permitted and how blinds are awarded.

Public safety concerns regarding vacation rentals on islands were discussed by Commissioners. When asked, lke McRee, County Attorney, said a plat for island development, as a note to potential buyers, should require a statement that no county services are to be provided to the island.

After Board discussion, Commissioner Beaumont moved to approve PB 19-21, Island Development Text Amendment, with the language as reflected in the most recent version as presented. At the suggestion of the County Attorney, Commissioner Beaumont amended his motion to include supporting policy moved to approve PB 19-21, Island Development Text Amendment, because the request is consistent with the land use plan Policy HN4. And, the request is reasonable and in the public interest because as a core value of being an American citizen we have the right to property rights. It will be the original developer's responsibility to inform all future homeowners, renters, visitors, etc. that emergency services, fire and rescue, law enforcement, etc. will not be available to the island.

Commissioner J. Owen Etheridge seconded the motion. The motion carried on a vote of 5-2 with Commissioners Payment and McCord opposed.

NEW BUSINESS

A. Ordinance Amending Chapter 2, Article III, Division 3: Fire and Emergency Medical Services (EMS) Advisory Board, to Provide One Resident Appointment from Knotts Island and One Resident Appointment from Corolla and to Increase Membership on the Fire and EMS Board from Five to Seven

County Attorney, Ike McRee, reviewed the ordinance amendment with the Board which increases the Fire and Emergency Medical Services Advisory Board (FEAB) membership by two, adding one district representative from Knotts Island and one from Corolla. It also provides for monthly meetings rather than quarterly.

Commissioner J. Owen Etheridge suggested changing the appointments from Consensus and allow each Commissioner to appoint a member. It was determined, however, that the membership composition established in the ordinance would not provide each Commissioner with an individual appointment.

There was no further discussion and Commissioner Beaumont moved to approve the ordinance as presented. The motion was seconded by Commissioner Payment. The motion passed, 7-0.

AN ORDINANCE OF THE CURRITUCK COUNTY BOARD OF COMMISSIONERS AMENDING CHAPTER 2, ARTICLE III, DIVISION 3 OF THE CURRITUCK COUNTY CODE OF ORDINANCES BY ADDING TWO ADDITIONAL BOARD MEMBERS AND AUTHORIZING MONTHLY BOARD MEETINGS

WHEREAS, pursuant to N.C. Gen. Stat. §153A-76 a board of commissioners may change the composition and manner of selection of boards, commissions, and agencies, and may generally organize and reorganize the county government in order to promote orderly and efficient administration of county affairs; and

WHEREAS, pursuant to N.C. Gen. Stat. §153A-77 a board of commissioners may appoint advisory boards, committees, councils and agencies composed of qualified and interested county residents to study, interpret and develop community support and cooperation in activities conducted by or under the authority of the board of commissioners.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners for the County of Currituck, North Carolina as follows:

PART I. The Code of Ordinances, Currituck County, North Carolina is amended by rewriting Chapter 2, Article III, Division 3 to read as follows:

DIVISION 3. FIRE AND EMS ADVISORY BOARD

Sec. 2-120. - Created.

The fire and emergency medical services advisory board is created pursuant to G.S. 153A-76.

Sec. 2-121. - Composition.

The fire and emergency medical services advisory board shall be composed of <u>five seven</u> members. Two members shall be a member of a volunteer fire department in the county, one member shall be the county emergency medical services director, one member shall be a member of the board of commissioners <u>and</u> one member shall be a public member who is a resident of the county, <u>one member shall be a resident of Knotts Island and one member shall be a resident of Corolla</u>.

Sec. 2-122. - Appointment and terms of members.

The volunteer fire department and public member of the fire and emergency medical services advisory board citizen shall be appointed by and serve at the pleasure of the board of commissioners in the manner set forth in sections 2-96 and 2-97. The initial fire and emergency medical services advisory board is to consist of two appointees for a term of one year and three appointees for a term of two years. Thereafter, all appointments are to be for terms of two years.

The commissioner serving as member shall be appointed by the board of commissioners on the first Monday in December to serve for a two-year term.

Sec. 2-123. - Compensation of members.

The volunteer fire department and public members of the fire and emergency medical services advisory board shall be paid the sum per meeting provided by the board of commissioners in the county fee schedule and shall be reimbursed for expenses incurred by them in the course of their duties upon the presentation of proper vouchers for those expenses.

Sec. 2-124. - Removal of members.

The board of commissioners shall have the right to remove any member appointed to the fire and emergency medical services advisory board at will and appoint a replacement member.

Sec. 2-125. - Duties.

The fire and emergency medical services advisory board is charged with the following duties:

- (1) review and make recommendations on volunteer fire department budget requests;
- (2) review and make recommendations on capital improvement project budget requests;
- (3) develop and implement volunteer firefighter retention and recruitment programs;
- (4) make recommendations to the board of commissioners for improvement to the fire protection and emergency medical services system;
- (5) investigate, study and make recommendations to the board of commissioners on any matter referred by the board of commissioners.

Sec. 2-126. - Function as advisory body.

The fire and emergency medical services advisory board shall have no legislative powers of its own but shall simply be an advisory body to the board of commissioners concerning the matters with which it is charged, and the board of commissioners will receive and consider the board's recommendations.

Sec. 2-127, - Officers.

The fire and emergency medical services advisory board shall appoint from its membership a chairman and any other officers as it may deem necessary for the orderly conduct of its business.

Sec. 2-128. - Meetings.

The fire and emergency medical services advisory board shall hold meetings once quarterly monthly and at hours as may be fixed by the board. Special meetings may be held on call of the chairman upon 48 hours' notice to the members of the board. A copy of the minutes of all meetings shall be sent to the county manager. All meetings or other business of the board shall be conducted in accordance with the Open Meetings Law.

PART II. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

PART III. This ordinance is effective immediately upon adoption.

B. Ordinance of the Currituck County Board of Commissioners Amending Chapter 9 of the County Code of Ordinances by Adding Article VI. Alarm Systems, and Section 1-8 Regarding Issuance of Notices of Violation, and to Make a Technical Correction

County Attorney, Ike McRee, reviewed the ordinance with Commissioners, which will provide for the issuance of violation notices for multiple false alarm calls.

During review, Commissioner Beaumont discussed possibly increasing the fine, established at \$250 in the ordinance, and expanding the time from thirty days to twelve

months for which a notice of violation can be issued for two false alarms. After discussion, the Board made no changes to the language.

Commissioner Beaumont moved to approve the Ordinance of the Currituck County Board of Commissioners amending Chapter 9 of the Currituck County Code of Ordinances by adding Article VI, Alarm Systems, and Section 1-8 regarding issuance of notices of violation and to make a technical correction. Commissioner Jarvis seconded the motion. The motion carried.

AN ORDINANCE OF THE CURRITUCK COUNTY BOARD OF COMMISSIONERS AMENDING CHAPTER 9 OF THE CURRITUCK COUNTY CODE OF ORDINANCES BY ADDING ARTICLE VI. ALARM SYSTEMS AND SECTION 1-8 REGARDING ISSUANCE OF NOTICES OF VIOLATION AND TO MAKE A TECHNICAL CORRECTION

WHEREAS, pursuant to N.C. Gen. Stat. §153A-121 a county may by ordinance define, regulate, prohibit, or abate acts, omissions, or conditions detrimental to the health, safety, or welfare of its citizens; and

WHEREAS, the Board of Commissioners has determined that alarm systems transmitting false alarms endangers public safety first responders and compromises emergency response systems.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners for the County of Currituck as follows:

PART I. Chapter 9 of The Code of Ordinances, Currituck County, North Carolina is amended by adding ARTICLE VI. ALARM SYSTEMS to read as follows:

ARTICLE VI. ALARM SYSTEMS

Sec. 9-100. - Definitions.

For the purpose of this article, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

<u>Alarm signal means detectable signal, audible or visual, generated by an alarm system, to which law enforcement or fire department is expected to respond.</u>

Alarm system means any single device or assembly of equipment designed to signal the occurrence of an illegal or unauthorized entry or other activity requiring immediate attention and to which law enforcement or fire department is expected to respond, but does not include alarms installed in motor vehicles, domestic violence alarms, or alarms designed to elicit a medical response.

<u>Alarm user means any person, corporation, partnership, proprietorship, governmental or educational entity, or any other entity owning or leasing an alarm system, or on whose premises an alarm system is maintained for the protection of such premises.</u>

Communication: Minutes for December 2, 2019 (Approval Of Minutes-December 2, 2019, and December 20, 2019)

Automatic dial protection device means an automatic dialing device or an automatic telephone dialing alarm system, and shall include any system which, upon being activated, automatically initiates to the county's communications center, Sheriff's Department or fire department a recorded message or code signal indicating a need for emergency response.

False alarm means the activation of an alarm system through mechanical or electronic failure, malfunction, improper installation, or the negligence of the alarm user, his or her employees, or agents, and signals activated to summon law enforcement or fire department personnel unless the alarm user or his or her agent canceled law enforcement or fire department response before law enforcement or fire department personnel arrive at the alarm location. An alarm is false within the meaning of this article when, upon inspection by law enforcement or fire department, evidence indicates that no unauthorized entry, robbery, or other such crime was committed or attempted in or on the premises or no evidence indicates the necessity of fire department response that would have activated a properly functioning alarm system. Notwithstanding the foregoing, a false alarm shall not include an alarm that can reasonably be determined to have been caused or activated by unusually violent conditions of nature nor does it include other extraordinary circumstances not reasonably subject to control by the alarm user. In addition, an alarm activated during an alarm system testing procedure shall not be considered a false alarm if the alarm user first notifies and receives permission from the user's alarm company, or designee, to test the system.

Local alarm means an alarm system that emits a signal at an alarm site that is audible or visible from the exterior of a structure and is not monitored by a remote monitoring facility.

Runaway alarm means an alarm system that produces repeated alarm signals that do not appear to be caused by separate human action.

Sec. 9-101. - Duties of the alarm user.

An alarm user shall:

- a. Maintain the premises and the alarm system in a manner that will reduce or eliminate false alarms;
- Make a solemn endeavor to respond or cause a representative to respond to the alarm system's location within 30 minutes when notified by law enforcement or fire department to deactivate a malfunctioning alarm system, to provide right of entry to the premises, or to provide alternative security for the premises; and
- c. Not manually activate an alarm for any reason other than an occurrence of an event that the alarm system was intended to report or to perform routine maintenance as prescribed by alarm system provider.

Sec. 9-102. - Prohibited acts.

It shall be a violation of this article to activate an alarm system for the purpose of summoning law enforcement when no burglary, robbery, or other crime dangerous to life or property is being committed or attempted on the premises, for the purpose of summoning a fire department when no fire event is occurring or otherwise to cause a false alarm.

- b. It shall be a violation of this article to install, maintain, or use an audible alarm system that can sound continually for more than 15 minutes.
- c. It shall be a violation of this article to install, maintain, or use an automatic dial protection device that reports, or causes to be reported, any recorded message to the county's communications center, Sheriff's Department or fire department.

Sec. 9-103. - Enforcement of provisions.

a. Excessive false alarms. It is hereby found and determined that two or more false alarms within a thirty day period is excessive, constitutes a public nuisance, enforceable by an equitable action, and shall be unlawful and a violation of this article. Civil penalties for false alarms within a year may be assessed against an alarm user as follows:

Second and over false alarms \$250.00

b. Civil noncriminal violation. A violation of any of the provisions of this article shall be a civil violation and shall not constitute a misdemeanor or infraction, enforceable under G.S. § 14-4, which expressly shall not apply.

Sec. 9-104. - Appeals.

- a. Appeals process. Assessments of civil penalty(ies) and other enforcement decisions made under this article may be appealed by filing a written notice of appeal with the county manager or county manager's designee within ten days after the date of notification of the assessment of civil penalty(ies) or other enforcement decision. The failure to give notice of appeal within this time shall constitute a waiver of the right to contest the assessment of penalty(ies) or other enforcement decision. Appeals shall be heard through an administrative process established by the county. The hearing officer's decision is subject to review in the district court by proceedings in the nature of certiorari.
- b. Appeal standard. The hearing officer shall review an appeal from the assessment of civil penalty(ies) or other enforcement decisions using a preponderance of the evidence standard. Notwithstanding a determination that the preponderance of the evidence supports the assessment of civil penalty(ies) or other enforcement decision, the hearing officer shall have the discretion to dismiss or reduce civil penalty(ies) or reverse any other enforcement decision where warranted.

PART II. Section 1-8(f)(g)(I) and (j) of The Code of Ordinances, Currituck County, North Carolina are amended to read as follows:

- (f) The provisions of this Code and any other town county ordinances may be enforced by one, all or a combination of the remedies authorized and prescribed by this section; except that any provision the violation of which incurs a civil penalty shall not be enforced by criminal penalties.
- (g) Except as otherwise specifically provided, each day's continuing violation of any provision of this Code or any other town county ordinance shall be a separate and distinct offense.
- (I) Upon determination of a violation of any section of this Code, the penalty for which is a civil penalty, the county shall cause a warning citation to be issued to the violator, setting out the nature of the violation, the date of the violation and an order to immediately cease the violation or, if the violation is in the nature of an infraction for which an order of abatement would be appropriate in a civil proceeding, stating a

reasonable period of time in which the violation must be abated. The warning citation shall specify that a second citation shall incur a civil penalty. The initial issuance of a warning citation upon a violator as provided above shall not be required for the immediate imposition of civil penalties for a determination of a violation of any of the following provisions:

- (1) Chapter 3, section 3-36;
- (2) Chapter 8, article IV;
- (3) Chapter 9, section 9-1, section 9-4, section 9-7, section 9-33; , article VI;
- (4) Chapter 10;
- (5) Chapter 12, article IV, section 12-62.
- (i) Upon failure of the violator to obey the warning citation, a civil citation shall be issued by the appropriate official of the town county and either served directly on the violator or his duly designated agent, or registered agent if a in person or posted in the United States mail service by first class mail addressed to the last known address of the violator as contained in the records of the town county, or obtained from the violator at the time of the issuance of the warning citation. The violator shall be deemed to have been served upon the mailing of such citation. The citation shall direct the violator to appear before the town treasurer county finance officer, located in the town hall, within 15 days of the date of the citation or alternatively to pay the citation by mail. The violation for which the citation been corrected by the time the citation is paid; otherwise, is issued must have further citations shall be issued. Citations may be issued for each day the offense continues until the prohibited activity is ceased or abated. Within a 12-month period, any repeat violation for which a notice of violation, warning citation, or civil citation has been issued shall be considered a continuation of the original violation.

PART II. Severability. Should any section or provision of this ordinance be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the ordinance as a whole or any part thereof other than the part declared to be invalid or unconstitutional.

PART III. Effective date. This ordinance shall be effective immediately upon its adoption.

WHEREAS, the filing fee for the office shall be determined by reference to the reduced salary; and

WHEREAS, the Board of Commissioners finds that it is appropriate to establish the entry level annual salary for the Office of Register of Deeds commensurate with similar entry level salary in the region.

NOW, THEREFORE, BE IT RESOLVED by the Currituck County Board of Commissioners that:

- 1. The annual salary for the Office of the Register of Deeds is hereby established at \$55,831.74.
- 2. The filing fee for the Office of the Register of Deeds shall be determined by the above referenced salary.

- a. He may execute contracts for construction or repair projects which do not require formal competitive bid procedures.
- b. Resolution of the Currituck County Board of Commissioners Opposing Reclassification of Jurisdictional Waters

WHEREAS, in January of 2019, the NC Marine Fisheries Commission (MFC) and the NC Wildlife Resources Commission (WRC) formed a joint committee for the purpose of determining boundaries defining inland and coastal waters; and

WHEREAS, the joint committee had its last meeting in May of 2019, after having disagreements between the agencies on the "salinity value" to determine boundaries; and

WHEREAS, in August of 2019, the WRC business meeting was held with little direct notice to the MFC or to the NC Department of Environmental Quality (NCDEQ). At this meeting the WRC decided to move forward with the proposed boundaries based on the arbitrary "2.6 ppt salinity value"; and

WHEREAS, in 2017 the MFC conducted a review of rules pertaining to delineation (15A NCAC 03Q .0200 et seq) and determined there was no basis to adjust jurisdictional boundaries; and

WHEREAS, the proposed Reclassification of Jurisdictional Waters would be a loss of approximately 144,984 square acres or 226.5 sq. miles of coastal and commercial fishing waters. Thus, creating even more confusion and regulations to the already over regulated NC commercial fishing industry; and

WHEREAS, the MFC would be required by law, to perform a comprehensive financial analysis to modify jurisdictional boundaries, which would include a review of all existing rules and a detailed mapping effort expected to take over a year to complete with added costs to the taxpayers of North Carolina; and

WHEREAS, the financial impact as proposed would exceed \$1,000,000.00 for sustainable economic impact as prescribed in the NC Administrative Procedure Act; and

WHEREAS, fisheries management plans of important commercial and recreational species under MFC authority follow a criterion initially to establish coastal and joint waters but not inland waters. Thus, a complete review of all MFC rules would have to be completed at NC taxpayer expense.

THEREFORE, BE IT RESOLVED, that the Currituck County Board of Commissioners strongly opposes the Reclassification of Jurisdictional Waters as prescribed by the NC Wildlife Resources Commission. Under such research we have not found where a Salinity Value is a determination of boundary lines between coastal and inland waterways.

WHEREAS, radon is a colorless, odorless, radioactive gas that may threaten the health of our citizens and their families; and

WHEREAS, radon is the second leading cause of lung cancer in the U.S. and is the leading cause of lung cancer in non-smokers; and

WHEREAS, the National Academy of Sciences estimates that up to 21,000 lung cancer deaths occur in the United States each year; and

WHEREAS, one in 15 homes across the U.S. have elevated radon levels; and

WHEREAS, any home may have elevated levels of radon, even if neighboring homes do not, and living in a home with an average radon level of 4 picocuries per liter of air poses a similar risk of developing lung cancer as smoking half a pack of cigarettes a day; and

WHEREAS, testing for radon is simple and inexpensive and radon problems can be fixed: and

WHEREAS, the U.S. Surgeon General, the U.S. Environmental Protection Agency, the NC Department of Health and Human Services' NC Radon Program, the North Carolina Advisory Committee on Cancer Coordination and Control, and the Board of Commissioners support efforts to encourage homeowners to test for radon and have elevated levels of radon reduced; and

WHEREAS, many residents in Currituck County don't know about radon, yet need to know for the safety and health of their families, and a proclamation of National Radon Action Month is an opportunity to educate individuals on the available measures to reduce radon.

NOW, THEREFORE, the Currituck County Board of Commissioners does hereby proclaim **JANUARY, 2020**, as **National Radon Action Month** in Currituck County, North Carolina.

Safe at Home: Preventing Lung Cancer

BY REDUCING RADON IN THE HOME

What is radon? Radon is a gas that you cannot see, smell or taste. It comes from the decay of radioactive elements (such as uranium, thorium and radium) in soil and groundwater.

What are your chances for getting lung cancer from

radon? Each one of the following influences your risk:

- 1. Level of radon in your home;
- 2. The amount of time you spend in your home;
- If you are a smoker of tobacco or have ever smoked tobacco;
- If you are exposed to secondhand smoke.



Why should I be concerned about radon?

Breathing in radon is the second leading cause of lung cancer after smoking. Radon is the likely cause of more than 21,000 lung cancer deaths each year in the U.S. In 2015, lung cancer was the leading cause of cancer deaths in N.C.

How does radon cause lung

cancer? Radon gas decays into radioactive particles that can get trapped in your lungs when you breathe. These particles break down and release small bursts of energy.

This can damage lung tissue and lead to lung cancer over the course of your lifetime. Not everyone exposed to high levels of radon will develop lung cancer, however the risk for lung cancer is increased.

How does radon get into a

home? Radon can rise from the rocks in the ground, through the soil, and to the air above. It comes into your home through cracks and holes in the foundation. The radon becomes trapped in your home. This can happen in new and old homes, homes with or without basements, and in high-rise and multi-family buildings. Underground well water can transport radon from the soil into the house.



Nearly one out of every 15 homes in the U.S. is likely to have a high level of radon. Homes in all 100 counties of N.C. have tested at high levels for radon. The only way to know if your home has a radon problem is to test it. (continued)

in homes? No. Radon can get into any type of building. You and

your family are most likely to be exposed at home because you spend most of your time there.

What is considered a high level of radon in

the home? The amount of radon in the air is measured in "picocuries per liter of air," or "pCi/L." A radon level in the home between 2 and 4 pCi/L is considered moderate risk and over 4 pCi/L is considered high risk for your health.

I am buying/selling a home. How do I get a property tested for radon?

There are no laws in N.C. regarding radon testing. The N.C. Radon
Program recommends that you hire a certified radon contractor. This will give you reliable test results quickly. If you get your water from a well, you can test your groundwater for radon with a certified laboratory. Visit www.ncradon.org to find a certified radon tester.

What if the radon levels are high in my home? Can my home be fixed? The EPA (U.S.

Environmental Protection Agency)
recommends fixing homes that have
an average radon level over 4 pCi/L.
The EPA suggests you consider fixing
your home if it tests between 2 and 4
pCi/L. Most homes can easily be fixed
to bring the radon levels below 4 pCi/L.
Lowering high radon levels requires special
knowledge and skills. Pick a contractor who
is trained to fix radon problems. The National
Radon Proficiency Program or the National
Radon Safety Board certifies trained contractors.

in water? The N.C Division of Public Health recommends testing well water for radon. Its experts say you should fix well water that tests high for radon. If the radon level is high in the well water, a second test for other types of radioactive particles like uranium and radium should be done. Select a contractor who is trained to fix radon problems. Contact your county health department's environmental health program for more information.

What will fixing my home cost me? In 2017.

the average cost for fixing a radon problem in an existing home was \$1,500. The average cost to include a radon reduction system when building a new home was \$800. The cost for a private well water radon treatment system ranges between \$1,500 - \$5,000. Visit www.ncradon.org to learn more about building Radon Resistant New Construction.

Will a radon reduction system impact the sale of my home?

Radon reduction systems have been installed in homes across N.C. since 1996. It is commonplace for national home building companies to install Radon Resistant New Construction in their new homes. Having a radon system in your home has not caused any problems for home sales.

- N. If, at the expiration of the family and/or medical leave without pay period, an employee fails to report for duty, and no extension of the leave without pay has been granted, then the failure to report is deemed a resignation.
- O. Periods of paid leave and periods of leave without pay count towards the FMLA 12 week entitlement. This includes Workers' Compensation leave and shared leave and will run concurrently.
- P. Job Restoration: Most employees granted leave will be returned to the same position held prior to the FMLA leave or one that is equivalent in pay, benefits, and other terms and conditions of employment. Certain highly compensated salaried employees (key employees) are eligible for leave, but are not guaranteed restoration to their position if they choose to take leave.
- Q. Military Caregiver Leave: THE FMLA Act provides an eligible employee with up to 26 weeks of unpaid leave within a "single 12 month period" to care for the serious injury or illness or a spouse, child, parent or next of kin who is a member of the Armed Forces, including National Guard or Reserves. <u>Military caregiver leave also allows an eligible employee who is the spouse, son, daughter, parent, or "next of kin" of a covered veteran with a serious injury or illness to take up to a total of 26 workweeks of unpaid leave during a "single 12-month period" to provide care for the veteran.</u>

A veteran who is undergoing medical treatment, recuperation, or therapy for a serious injury or illness is a covered veteran if he or she: was a member of the Armed Forces (including a member of the National Guard or Reserves); was discharged or released under conditions other than dishonorable; and was discharged within the five-year period before the eligible employee first takes FMLA military caregiver leave to care for him or her.

- R. A serious injury or illness is defined as an injury or illness that the service member incurred in the line of duty, while on active duty, that renders them medically unfit to perform the duties of their office, grade, rank or rating. The "single 12 month period" for Military Caregiver Leave begins on the first day the employee takes leave for this reason and ends 12 months later. Documentation and certification requirements can be found at the following links:https://www.dol.gov/whd/regs/compliance/whdfs28mb.pdf and https://www.dol.gov/whd/regs/compliance/whdfs28ma.pdf.
- S. Qualifying Military Exigencies include but are not limited to short notice deployment (seven or less days of notice prior to deployment, military events and related activities, making financial and legal arrangements, postdeployment activities, any other event that the employee and County agree is a qualifying military exigency.
- T. Grievance Procedure: It is the policy of Currituck County not to discharge or discriminate against any employee exercising his/her rights under the FMLA.

- The abuse of client(s), patient(s), student(s) or a person(s) over whom the employee has charge or to whom the employee has a responsibility, or of an animal owned or in the custody of the County;
- Falsification of an employment application or other employment documentation:
- Insubordination which is the willful failure or refusal to carry out a reasonable order from an authorized supervisor;
- Absence from work after all authorized leave credits and benefits have been exhausted.
- C. Unsatisfactory Job Performance A basis for discipline or dismissal. Disciplinary actions for unsatisfactory job performance do not require prior warnings for the same type of performance problem. Written warnings are given with the intention of permanently improving job performance; however, if the improvement later deteriorates or if other unsatisfactory job performance occurs, the supervisor may proceed to the next level of discipline. No maximum number of warnings are required. Unsatisfactory job performance is defined as a deficiency in work performance including, but is not limited to,:
 - violation of, or failure to follow work rules;
 - inattention to or negligence of the duties of one's position;
 - failure to meet production or accuracy standards;
 - poor work habits:
 - excessive tardiness and absenteeism;
 - failure to follow instructions, directions, or procedures (this can also be considered personal conduct);
 - poor work quality and quantity;
 - timeliness in the performance of work-related analysis, decisions, or judgment.
 - Failure to turn in payroll timesheet by deadline.
- D. Grossly Inefficient Job Performance A basis for discipline and dismissal. Occurs in instances in which the employee fails to perform job requirements satisfactorily as specified in the job description, work plans, or as directed by the management of the work unit or the County and the employee's failure results in:
 - the creation of the potential for death or serious harm to a client(s), an employee(s), members of the public or to a person(s) over whom the employee has responsibility;
 - the loss of or damage to any County property or funds that result in a serious impact on the County and/or work unit;
 - the substantial increase in potential liability or loss of credentials or revenue for the County, or;





CURRITUCK COUNTY JOB DESCRIPTION

JOB TITLE: LIEUTENANT DEPARTMENT OF FIRE-EMERGENCY MEDICAL SERVICES

GENERAL STATEMENT OF JOB

Under general supervision, assists in developing, designing, coordinating, implementing and monitoring standards and policies of the Currituck County Emergency Medical Services system; functions as key liaison and consultant with all EMS and volunteer fire department personnel, and other essential public safety departments within the county. Serves as an immediate supervisor to an assigned group of department personnel; managing and supervising staff engaged in Fire/EMS duties, daily operations of the department, and resource management. Performs in accordance with established emergency medical procedures and protocols approved by the local medical director at the NC EMT-Paramedic level and must exercise considerable independent judgment to assess conditions of patients and administer appropriate medical treatment. Work is subject to both inside and outside environmental conditions, extremes in temperatures, noise, vibrations, exposure to fumes, odors, dusts, mists, gases, poor ventilation, and oils. Due to the nature of the work, employee is exposed to human blood and is subject to the OSHA requirements on blood borne pathogens. Participates in firefighting activities to include: driving fire apparatus, operating fire department equipment, fighting fires and extricating patients. Reports to the Shift Captain.

SPECIFIC DUTIES AND RESPONSIBILITIES

ESSENTIAL JOB FUNCTIONS (LIEUTENANT)

Assist EMS Captain with the development, coordination, and implementation of the policies, procedures, and guidelines for the department; reviewing system plan and other applicable policies for accuracy and compliance with local, state, and federal regulations.

Manage shift schedule, vacation and sick time requests, and exchange of duty requests; ensuring each shift and EMS unit is staffed appropriately; employee's requests for vacation, sick time, and exchange of duties are within department and county policies.

Procurement and maintenance of supply inventory and equipment; develop cost effective measures for the purchasing of supplies and equipment; submit monthly requests to the Appropriate Captain/Supervisor for supplies needed; evaluate new products and equipment for future use; establish and update preventive maintenance procedures for equipment in accordance with manufacture recommendations; monitor use for budgetary planning; keep perpetual inventory of supplies and equipment using an electronic database.

Implement, coordinate, and maintain a vehicle maintenance program for all department vehicles that is consistent with manufacture's recommendations; schedule vehicles for required maintenance and repair, ensuring vehicles are delivered and retrieved appropriately; conduct routine repairs and maintenance procedures not requiring an automotive technician (i.e. changing light bulbs, checking fluid levels, replacing fuses, etc); develop and maintain electronic database of repair requests and maintenance.

Ensure daily operations of the department are met; personnel are reporting to work on-time and in proper dress and with appropriate personnel protective equipment; delegate assignments and instructions to shift personnel; keeps department personnel abreast of pertinent information to their mission and daily operations; if required, fills in as crew member on opens shifts until a suitable replacement can be found; delivery and retrieval of supplies and equipment; retrieving and reviewing patient care reports for accuracy and compliance with applicable policies, forwarding discrepancies to EMS Captain and/or Deputy Chief for review.

Conduct on-shift training and skills assessment with shift personnel; develop cohesiveness between shift personnel, EMS and fire department volunteers; training shall be done in cooperation with the EMS Captain and shall include equipment and product in-service, skills and procedure development, annual required training, and other such training deemed necessary by the Shift Captain, Training Officer or Deputy Chief.

ESSENTIAL JOB FUNCTIONS

Responds to calls for medical aid including motor vehicle collisions, rescue operations, and any other incident were EMS has been requested. Provides prehospital care at the EMT-Paramedic level including, but not limited to, examining patients and monitoring vital signs, administration of medications, insertion of airway devices including a blind insertion airway device, tracheal intubation and cricothyrotomy; use of cardiac monitors to acquire, interpret and transmit 12-Lead EKG's, defibrillation, synchronized cardioversion, and external transcutaneous pacing; chest decompression; collection of blood for laboratory analysis, establishes peripheral and intraosseous intravenous access; other basic and advanced first aid and life support actions as approved by the North Carolina Medical Board and the Currituck County EMS Medical Director; communicates with hospital and/or health care professionals in person or by radio; completes required reports. Restocks supplies and maintains emergency vehicles and equipment in proper working conditions.

Conduct and participate in drills and training exercises; develop skills in fire suppression, complete 36 hours of fire department training annually. Participates in a continuous training program to improve competence in medical clinical work and in ambulance service and operation; maintains knowledge of new or modified operational protocols; complete 36 hours of EMS continuing education training annually.

In a fire emergency, assists the volunteer fire departments, performing basic firefighting duties and responsibilities within permissible limits; drive and operate fire apparatus with specific ability to respond a pumper or tanker to the scene of an incident and obtain water flow, perform exterior (and interior if_qualified as determined by Fire/EMS Chief) fire ground operations; assist firefighters in the handling of fire hoses, ladders, SCBA equipment, manpower rehabilitation, and other vital equipment and functions; assists with the extrication and removal of entrapped or confined patients.

Prepare, submit, and maintain reports on emergency medical services activities, fire suppression activities, incidents and accidents, and other related information; prepare clear and concise documentation; obtaining medical data including patient identification, medical history, type of accident or nature of illness, rescue measures, preceding emergency care, care given at an emergency medical scene; direct patient care and transport.

Operate, inspect, inventory, and maintain emergency response equipment and vehicles; perform minor repairs on equipment and vehicles or report deficiencies to proper staff for other disposition; order necessary supplies; clean and maintain patient compartment and cabinets of emergency vehicles; ensures proper supplies and equipment are stocked and functions properly.

Perform general maintenance and cleaning of station; sweep and mop floors, light dusting, and clean windows; cleaning of restrooms and bathrooms, keeping bunkrooms neat with beds made in a neat and clean manner; changing sheets and pillow cases after each use, laundry as necessary.

Work with the community in a variety of educational, public relations, and service programs; fire prevention, safety awareness, community CPR training, and public school activities for EMS standby.

ADDITIONAL JOB FUNCTIONS

Ensure that all personnel maintain current skills and develop additional ones as appropriate by conducting needs assessments, and/or developing, administering and participating in training activities.

Meet with shift personnel to discuss problems, events, current information, and the handling of past emergencies to improve future performance.

Assist the Shift Captains in employee performance appraisals for department personnel assigned to their shift; document performance measures, commendation and disciplinary actions, and needs assessment; establish appropriate goals and objectives for individuals, provide encouragement and resources for those goals to be met.

Explain and enforce policies and procedures, disciplining staff in a fair and equal manner as necessary; properly and effectively intervene to settle an argument or some interpersonal problem among staff; notify a superior of a problem and recommend a course of action for solution.

Work with the EMS and fire department volunteers to enhance the overall operation and function of the departments, local volunteer fire departments and other county entities.

Performs duties as assigned by the County Manager, Fire-EMS Chief or his designee, during a State of Emergency or other disaster.

Performs other related work as required.

JOB RESPONSIBILITIES RELATED TO HIPAA COMPLIANCE

Is expected to protect the privacy and security of all protected health information (PHI) and electronic PHI (e-PHI) in accordance with Department privacy and security policies, procedures, and practices, as required by federal [and state] law, and in accordance with general principles of professionalism as a health care provider. Failure to comply with the Department's policies and procedures regarding the privacy and security of PHI and e-PHI may result in disciplinary action up to and including termination of employment.

May access PHI and e-PHI only to the extent that is necessary to complete job duties and may only share such information with those who have a need to know specific patient information to complete their job responsibilities related to treatment, payment or other company operations.

Is encouraged and expected to report, without the threat of retaliation, any concerns regarding the Department's policies and procedures on patient privacy or security and any observed practices in violation of those policies to the designated Privacy/Information Security Officer.

Is expected to actively participate in Department privacy and security training and is required to communicate privacy policy information to coworkers, students, patients and others in accordance with Department policy.

MINIMUM TRAINING AND EXPERIENCE

High school diploma or equivalent with vocational or technical school training as an Emergency Medical Technician-Paramedic; NC (or other equivalent) Firefighter II certification <u>preferred</u>. Any equivalent combination of training and experience which provides the required skills for the job functions, knowledge and abilities may be substituted; and

Credentialed by the North Carolina Office of Emergency Medical Services as an Emergency Medical Technician-Paramedic as outlined in 10A NCAC 13P .0502;

Current Basic Life Support, Healthcare Provider (CPR) provider certification, or equivalent;

Current Advanced Cardiac Life Support, Pediatric Advanced Life Support, or equivalent. PEPP may be substituted for PALS. Obtain PHTLS within one year of employment date.

Emergency Vehicle Operator Certification, CEVO or equivalent.

SPECIAL REQUIREMENTS

Must possess a valid driver operator license.

Successfully complete Incident Command System-100, 200, 300 and the National Incident Management System-700 and 800.

Maintain the privilege to practice within the Currituck County EMS system; Successfully pass the Technical Scope of Practice evaluation, valid Basic Life Support, Healthcare Provider (CPR) certification, Advanced Cardiac Life Support, Pediatric Advanced Life Support, 36 hours of continuing education per year.

Completion of Bloodborne Pathogens and HIPAA compliance training, and participates in an annual refresher.

MINIMUM QUALIFICATIONS OR STANDARDS REQUIRED TO PERFORM ESSENTIAL JOB FUNCTIONS

<u>Physical Requirements:</u> Must be physically able to operate a variety of machinery and equipment, including stretchers, stair chairs, backboards, ladders, various fire hoses, and extrication equipment. Must be physically able to operate a motor vehicle, including fire apparatus and other emergency vehicles. Must be able to exert in excess of 100 pounds of force occasionally, and/or up to 75 pounds of force frequently, and/or 20 pounds of force constantly to move objects. Requires the ability to maintain body equilibrium when bending, stooping, crouching, climbing, reaching and/or stretching arms, legs or other parts of body, and to physically maneuver over and/or upon varying terrain, surfaces or physical structures. Physical demand requirements are for Very Heavy Work.

<u>Data Conception:</u> Requires the ability to compare and/or judge the readily observable, functional, structural or composite characteristics (whether similar or divergent from obvious standards) of data, people or things.

<u>Interpersonal Communication:</u> Requires the ability to speak and/or signal people to convey or exchange information. Includes receiving instructions, assignments or directions from superiors.

Language Ability: Requires the ability to read a variety of correspondence, reports, logs, etc. Requires the ability to prepare a variety of reports, forms, logs, invoices, etc., using prescribed formats. Requires the ability to speak to people with poise, voice control and confidence.

<u>Intelligence:</u> Requires the ability to apply principles of logical or scientific thinking to define problems, collect data, establish facts, and draw valid conclusions; to interpret an extensive variety of technical instructions in mathematical or diagrammatic form; and to deal with several abstract and concrete variables.

<u>Verbal Aptitude:</u> Requires the ability to record and deliver information, to explain procedures, to follow oral and written instructions. Must be able to communicate effectively and efficiently in a variety of technical or professional languages, including medical terminology and emergency response codes.

Numerical Aptitude: Requires the ability to utilize mathematical formulas; to add and subtract; multiply and divide; calculate decimals and percentages.

Form/Spatial Aptitude: Requires the ability to inspect items for proper length, width and shape.

<u>Motor Coordination:</u> Requires the ability coordinate hands and eyes rapidly and accurately in lifting and positioning or transporting objects, and operating motor vehicles.

<u>Manual Dexterity:</u> Requires the ability to handle a variety of items, such as control knobs, toggle switches, syringe plungers, levers, hand tools, etc. Must have minimal levels of eye/hand/foot coordination.

Color Discrimination: Requires the ability to differentiate between colors and shades of color.

<u>Interpersonal Temperament:</u> Requires the ability to deal with people beyond giving and receiving instructions. Must be adaptable to performing under stress and when confronted with persons acting under stress, and in emergency situations.

<u>Physical Communication:</u> Requires the ability to talk and hear: (Talking: expressing or exchanging ideas by means of spoken words. Hearing: perceiving nature of sounds by ear.) Must be able to communicate via telephone and two-way radio.

KNOWLEDGE, SKILLS AND ABILITIES

Working knowledge of the Currituck County emergency medical policies, procedures, and treatment protocols.

Working knowledge of equipment and supplies employed in the emergency care of patients and emergency scenes.

Working knowledge of Incident Management Systems and procedures.

Working knowledge of Mass Causality Incident Management processes and procedures.

Working knowledge of County geography and of the location of roads and streets within the County, including location of frequently utilized medical facilities and landing zones.

Working knowledge of procedures of extrication, movement of patients, rescue techniques, transportation and psychological needs of a patient.

Working knowledge of radio communications equipment.

Ability to supervise and manage personnel.

Ability to coordinate and manage emergency and non-emergency incident scenes.

Ability to respond quickly and calmly to emergency situations.

Ability to lift substantial weight.

Ability to understand and follow oral and written instructions.

Ability to deal tactfully, courteously and firmly with the general public.

Ability to establish and maintain effective working relationships with as necessitated by work assignments.
