**Notice to the adjoining property owners shall include a statement indicating the comments or concerns regarding the issuance of a permit at the proposed location may be made to the Sheriff prior to the event.** These conditions are mandatory on all "permit to exceed" applicants.

**No permitted event may last more than four hours in duration and may not extend beyond 11:00 p.m.**

I understand that the issuance of this permit is **conditional upon compliance with all regulations and ordinances of the County of Currituck**. I agree to give my full cooperation to the Currituck County Sheriff's Office in enforcing the noise ordinance, to be present at the site of the event, and to be capable of assisting the Currituck County Sheriff's Office in their enforcement duties during the entire time for which this permit is issued. **I further understand that the issuance of a noise permit does not permit the noise level to create a nuisance but only permits the use of outdoor amplified sound and to exceed the normal noise limit level within the specified decibels.**
