Sealed bids will be received by Currituck County in the Corolla Satellite Office Conference Room located at 1123 Ocean Trail, Corolla NC on Tuesday, October 6, 2015 until 2:00 PM local time and immediately thereafter publicly opened and read, for constructing the following facilities:

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to Currituck County, Corolla Office, 1123 Ocean Trail, Corolla NC 27927 and the outside of the envelope must be marked "Bid for Currituck County Multi-Use Path, Corolla Greenway. All bids must be made on blank forms provided and included in the document. The name, address, and license number with limitation and classification of the Bidder must be plainly marked thereon.

Each bid must be accompanied by cash or a certified check, drawn on a bank or trust company authorized to do business in North Carolina, payable to Currituck County in an amount at least equal to five percent (5%) of the total amount of the bid, as a guarantee that a contract will be entered into. In lieu of cash or a certified check, the Bidder may submit a bid bond in the form prescribed in G.S. 143-129 as amended by Chapter 1104 of the Public Laws of 1951.

Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts.

Contractors are required to attend a mandatory Pre-Bid Conference to be held in the Corolla Library Multi-Purpose Room located at 1123 Ocean Trail, Corolla NC on Tuesday, September 22, 2015 at 10:30 AM local time. The Board of Commissioners has established a goal of 10% minority business participation for this project.

The major items of work include:

15,060 LF 10 ft. wide concrete multi-use path

800 LF 10 ft. wide wooden boardwalk with handrail

610 LF Wooden retaining wall

Approved NCDOT Traffic plan
