The Community Meeting was held as scheduled on Thursday, December the 4th. 71 Letters were sent, announcing the meeting and an approved sign was placed on the property at the required time. A private room and refreshments were provided by Cheyney Cole, developer's representative and partner. All the renderings that were provided to Planning Staff were enlarged onto card stock and were displayed on a large table. A copy of the site plan was also displayed. Questions asked generally revolved around home pricing, lot sizes, amenities and the fact that a fountain at the BMP on Caratoke would look good. Comments were very positive.

A common comment was that the 20-single family homes was a vast improvement over the townhome project that was presented recently. The renderings and lot sizes were also mentioned as positives. Several folks offered to speak on our behalf, of note was Wanda, the owner of BJ's Café. She has an immense and deep knowledge of almost everything related to "Lower Currituck!".

Jason from the Planning Department was also in attendance, by 6:30 the meeting room was empty as it was 'Burger Night' at BJ's and folks were hungry.
