Important Storm Preparation Reminders


- Maintain an emergency safety kit for your family and pets
- Review your emergency plan with all family members
- Make checklists for securing your property
- Make sure insurance policies are up-to-date
- Store important documents in waterproof containers
- Make a plan for pets and farm animals
- Discuss possible evacuation plans with relatives and friends
- Monitor trusted sources of information for updates and alerts, such as the National Hurricane Center
- Currituck County does not have pre-storm shelters, so please heed any evacuation orders that are issued

Trivia: How Many Lots Does It Take To Make A Subdivision?

Generally, a subdivision is understood as a neighborhood or residential area where a large piece of land has been divided into smaller lots for homes, with streets, sidewalks, and utilities planned as part of the development.

All land divisions must be reviewed for compliance with zoning and subdivision regulations, and unapproved divisions may not be recognized for development or permitting purposes.

But did you know that in North Carolina, a subdivision typically happens any time a single piece of land is divided into two or more lots? So, if you split one lot into two, that usually qualifies as a subdivision under state and local rules. Simply recording a new lot by deed does not necessarily create a legal, buildable lot.



Learn More About Local Landmark Status for Historic Properties

The Joseph S. Dey House was recently designated as a Currituck County landmark. Located at 2757 Caratoke Highway, it is a well-preserved example of vernacular I-House architecture rooted in traditional British folk design. The home is an example of simple yet distinct architecture prevalent in the Mid-Atlantic rural community.

A local historic landmark is a property so designated by the Board of Commissioners as one of special significance due to its architectural, archaeological, historical, and/or cultural importance.

Help Pipes Keep Flowing... Don't Use Your Toilet as a Trash Can

Help reduce sewer blockages and overflows by being mindful of what you flush down toilets. Making sure that only human waste and toilet paper are flushed can save valuable time and money on repairs.

Following is a list of common items which should **NOT** be flushed down a toilet. They cause blockages in pipes and lead to expensive repairs, often on the homeowner's property.

- Flushable wipes. They do not degrade and cause blockages
- Baby wipes and cleaning pads

- Feminine products and applicators
- Dental Floss
- Q-tips and cotton balls
- Food, fats, oils, or grease
- Diapers
- Paper towels and tissues
- Cigarette butts
- Cat litter
- Chewing gum
- Hair
- Pills and medicines
- Band aids
- Bleach, paint or chemicals
- Rags

Why It's Important To Keep Stormwater Ditches Clear

Stormwater management in Currituck County is a challenge that is complicated by low elevations, flat topography, high groundwater tables, and poorly drained soils. Keeping ditches clean is essential for effective stormwater management and preventing problems like flooding, erosion, and damage to roadways.

Ditches are designed to carry and redirect water. When ditches become filled with vegetation, sediment, or trash they lose their effectiveness because they cannot hold as much water and cannot provide effective flood protection to adjacent land or

roadways. Property owners play an important role in keeping ditches clean and clear.

Property owners should:

- Mow ditches to maintain proper water flow and prevent overgrowth that can block drainage. Well-maintained grass also helps filter stormwater naturally.
- Keep ditches clear of debris and trash. Especially during fall months, remove fallen leaves, branches, and organic debris that could obstruct water flow or create temporary dams.

Did You Know? In NC, Counties Do Not Build or Maintain Roads

The N.C. Department of Transportation (NCDOT) is responsible for all modes of transportation in North Carolina. This includes highways, rail, aviation, ferries, and bicycle and pedestrian transportation.

How do I know if my road is state maintained?
Visit NC OneMap - NCDOT State Maintained Roads online to determine if your road is state maintained.

My road is not a state road. How do I get my road added to the state system?

Private roads are the responsibility of the owner/developer or property owners. To request the NCDOT take over maintenance of non-system roads, the property owners along the road must petition the NCDOT to add it to the state's system. To obtain a petition and instructions for submission, contact the NCDOT Division 1, District 1 Field Office at 621-6400.

Trash/Recycling Waiver Applications Due 12/31

Applications for this year's Trash/Recycling Fee Waivers are being accepted now through December 31 for low-income homeowners. Eligibility is based on household income and the number of individuals living in the household. Proof of income is required.

Volunteer Fire Service Provides Immeasurable Benefits to You & the Community

It's true, volunteer fire service is vital for county fire protection and provides immeasurable benefits. Volunteer fire service is critical in rural communities like ours. **The services that volunteer fire departments provide save the community money by relying on unpaid volunteer time.** The expense of an alternative, county-wide paid fire service would be passed along to citizens as a property tax increase.

About volunteer fire service

There are five volunteer fire departments (VFD) in Currituck County: Moyock, Crawford Township, Lower Currituck, Corolla, and Carova Beach. Each of these departments responds to emergency calls within their respective districts and operates independently from Currituck County Fire-EMS. Fire-EMS provides county-wide emergency medical services and also maintains a paid fire service presence in the Knotts Island and Corolla communities. The paid fire service is funded through an

additional fire service district tax which is levied on and paid by residents living in those districts.



Currituck County contracts with and provides funding to each volunteer fire

department for operational and capital expenses. Operational expenses include training, vehicle maintenance, fuel, utilities, insurance, uniforms, and turnout gear. Examples of capital expenses include extrication tools, gas meters, and thermal imaging cameras. The current year county budget funds approximately \$1.8 million to volunteer fire departments which equates to 2 cents of the annual 62 cent property tax.

What does being a “volunteer firefighter” mean?

A volunteer firefighter is a community member who

provides fire protection and other emergency response services in their spare time from a primary job, but there is so much more to it than firefighting! A common misconception is that a person must be a firefighter, or have the ability to become one, to support a local VFD. Departments also need members to provide scene support, community outreach, fundraising, and administrative support.

Are you someone who enjoys interacting with others? Fundraising or public outreach would be a great fit for you.

Maybe you enjoy number-crunching and record-keeping? Great, your local VFD would love to have your administrative support.



The possibilities are endless, and we need your help.

Keep our tax rate steady by getting involved with your local volunteer fire department. There are so many ways to get involved and support your local VFD.

Family Caregiver Support Program Now Available in Currituck

Currituck Senior Services wants county residents to know there is a Family Caregiver Support Program (FCSP) available in our area!

A family caregiver is someone who provides unpaid care or support for a person age 60+ at home. The care recipient can be under the age of 60 if they have been diagnosed with Alzheimer's or a related dementia condition.

The FCSP can offer a range of services to support family caregivers:

- Information on available

- resources
- Support Groups and Workshops
- Respite care, which is a temporary break from caregiving responsibilities
- Supplemental services, such as incontinent supplies and liquid nutritional supplements

County Residents May Pick Up Free Opioid Overdose Safety Kits

Currituck County has opioid overdose kits available that include Narcan, the overdose reversal drug. Materials for the kits are obtained through state opioid settlement funds distributed to counties.

Angela Lottman, Opioid Program Coordinator, oversees the distribution and can help individuals or community groups obtain the free kits.



Feral Cat Caregivers Encouraged to Partner with Animal Services

Currituck County is making progress with its new Trap-Neuter-Return (TNR) program for feral cats. Animal Services & Control began the TNR program in March and by June 30 had neutered 11 feral cats and spayed 20 feral cats.

Services and the county arranges for medical services. To cover the costs of neutering/spaying, the county pays \$100 and the caregiver pays \$25 per cat. Afterwards, the caregiver releases the cat back to the area where it was trapped.

TNR is a cost-sharing program between the county and private citizens who act as caregivers for feral cats (someone who feeds the cats, etc.). Caregivers collects feral cats in humane traps provided by Animal

Fire-EMS First in Region to Utilize Advanced Airway Procedure

Currituck County Fire-EMS is proud to be the first EMS agency in northeast North Carolina to introduce a procedure that protects a patient's airway during critical emergencies.

Airway management is one of the most important steps in saving lives, especially for patients experiencing head trauma, stroke, or serious medical conditions that interfere with normal breathing. With this new protocol, a specially trained group of Currituck paramedics use carefully selected medications to make the process safer and more effective.

our team uses advanced video laryngoscopes, state-of-the-art equipment that improves accuracy and allows each procedure to be reviewed for quality and safety. Every use of this protocol is carefully monitored and reviewed at the local and state levels.



Since its launch on June 1, the procedure has proven to be a valuable tool in providing life-saving care to our community. Currituck Fire-EMS remains committed to bringing the latest innovations in emergency medicine to our citizens, so that when seconds count, our neighbors can count on us!

This year, staff also renewed its StormReady® status with the National Weather Service. StormReady helps communities strengthen plans for all types of hazardous weather including hurricanes, tornadoes, and winter storms by improving local operations through:

- Clear, consistent weather messaging
- Multiple reliable ways to receive and share warnings
- Ongoing preparedness and outreach events

“While we can’t stop the weather, preparing in advance of the events and knowing the actions to take when severe weather hits

can help mitigate its impacts and ultimately save lives,” said Eric Seymour, Warning Coordination Meteorologist, NWS Wakefield.

Citizens are also encouraged to regularly review emergency plans, update supply kits, and follow trusted sources information in order to be prepared when weather strikes.
