AN ORDINANCE OF THE CURRITUCK COUNTY BOARD OF COMMISSIONERS AMENDING SECTION 2-56 OF THE CURRITUCK COUNTY CODE OF ORDINANCES TO PROVIDE FOR REMOTE PARTICIPATION AT A MEETING DURING A STATE OF EMERGENCY

WHEREAS, pursuant to N.C. Gen. Stat. §153A-71 a board of commissioners may adopt its own rules of procedure in keeping with the size and nature of the board and in the spirit of generally accepted principles of parliamentary procedure; and

- WHEREAS, pursuant to N.C. Gen. Stat. §153A-76 a board of commissioners may change the composition and manner of selection of boards, commissions, and agencies, and may generally organize and reorganize the county government in order to promote orderly and efficient administration of county affairs.
- NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners for the County of Currituck, North Carolina as follows:
- PART I. Section 2-56(c) of the Code of Ordinances, Currituck County, North Carolina is amended to read as follows:
- 17 Sec. 2-56. Regular and special meetings.
- 18 (c) *Meeting attendance*. A board member must be physically present at a regular or special meeting to participate or vote in the meeting <u>except during a</u> 20 <u>state of emergency declared under Chapter 166A of the General Statutes of North</u>
- 21 Carolina when a majority of the board is unable to be physically present at the
- 22 <u>meeting</u>.
