Minutes – Special Meeting of the Board of Commissioners

### 5:00 PM CALL TO ORDER

The Currituck County Board of Commissioners held a Special Meeting at 5 PM in the Board Meeting room in the Historic Currituck Courthouse, 153 Courthouse Road, Currituck, NC. The purpose of the meeting was to hear responses to notices for cause of removal that were issued to two Currituck County advisory board members. ABC Board member Jerry Maleski received notice to answer to allegations made by Commissioner Gilbert that he had inappropriately touched her during a recent GOP political party meeting. Game Commission member William Curtis Austin was asked to respond due to a posting he made on his Facebook page that referred to his male anatomy and contained profanity. The post was brought to the attention of Commissioners via a citizen complaint.

**NEW BUSINESS**

**A. Receive a response from William Curtis Austin to a Notice of Cause for Removal as a Member of the Currituck County Game Commission for Consideration and Possible Action on Removal**

Chairman Griggs read a statement which described how comments on social media can negatively affect communities and recalled an earlier taken against an advisory board member due to similar circumstances.

After completing his statement, Chairman Griggs moved that the matter before the Board concerning Mr. Austin be dismissed, with the stipulation and requirement that staff bring to the Board, for review and adoption, a policy easily understood that will provide the various advisory boards future guidance.

Commissioner Aydlett seconded the motion.

Commissioner O'Neal agreed it would be appropriate to develop guidelines. He said it is incumbent on all, whether elected or an advisory member, to be perceived as professional and non-biased, and he expressed his desire to put animosity and discord in the past. He said he has seen how social media posts ruin families and friendships.

With no further discussion the motion passed unanimously.

Commissioner O'Neal moved to accept the resignation, adjourn the meeting, and dismiss the cause of action against Mr. Malesky. Commissioner Aydlett seconded and the motion was carried 6-0, with Commissioner Gilbert excused from voting.
