TO ALL PROSPECTIVE BIDDERS for the Carova Beach Park Bulkhead Repair for which bids are now to be received by Currituck County.

As follows below with the following revision to specifications and bid documents that are hereby made as part of the Contract Documents and Specifications for the above-mentioned project.

- 1. Fertilizing and Seeing Delete "REPAIR AND MAINTENANCE" and "ACCEPTANCE" sections from pages 4 and 5.
- 2. Revise: Carpentry Specification:

Revise: Lumber to be used for the construction of wooden handrails and decking will be #1-dense/dressed #2 premium/dressed.

Revise: Pressure Treated: Piles – Round and square piles <u>Rough or Dressed</u>, #2 dense Wales – Rough or Dressed, #2 dense Deadman – Rough or Dressed, #2 dense Joist – <u>Rough or</u> Dressed, #2 dense Decking – Dressed, #2 dense <u>Premium</u> Handrails – Dressed, #2 dense, <u>Premium</u> Girders – <u>Rough or</u> Dressed, #2 dense

 Revise: Driven Timber Piles/Wales/Deadman Specification: Wales: Square 6"x6" and 4"x6', rough <u>or dressed #2</u> #1 Boardwalk Boards - #2 <u>dressed</u>, premium <u>dense rough</u> Joist - #2 <u>rough or dressed dense dressed</u> Handrails - #2 <u>dense</u> dressed, premium

Add: Testing Agency:

Quality Control for test pile operations and test piles shall be performed by an Independent Testing Agency approved by the OWNER or ENGINEER, <u>paid for by the contractor</u>. Quality Control for the remaining piles will be at the discretion of the Engineer and or Testing Agency.

Delete "Dense" from multiple location in "Magnified View"

Revise – Note Wood Material (Railing and Deck Boards) are to be #2 dense-premium

5. Revised Bid Form to Add:
"Additive Bid Item 2: Extra 8" Diameter Pile Length due to load test results. There will be a deduct for length not used.

No additional unofficial or inferred information or conversations whatsoever different will be considered part of the contract documents other that those clearly stated on the Construction Drawings and all Items included on Addendum 2. No acknowledgement will be given to either party of any phone call or conversation of any kind regardless of location that has not been objectively discussed by the previous documents of subsequent Addenda.

All bidders shall understand that the Addenda are mandatory part of the Bid Documents, and therefore acknowledge unequivocally their receipt and acceptance of this <u>Addendum No. 2</u> by signing in the space provided and submitting the signed Addenda with the Bid. <u>Failure to</u> include the properly signed Addenda documents will be cause for rejection and dismissal of the bid.
