Subject: Addendum No. 2 to RFB for Currituck Family YMCA Partial Roof Replacement

This Addendum forms a part of the Contract Documents and modifies the Bidding documents dated September 24, 2025, with amendments and additions noted below. This Addendum must be acknowledged on the Bid Form. Failure to acknowledge receipt of Addendum No. 2 may result in your submission being declared non-responsive.

The HUB forms were inadvertently not included in the original bid package. These forms are attached. To accommodate the good faith effort requirements, the Bid Opening will be rescheduled for **November 13**, **2025** at 2:00pm at the Currituck County Historic Courthouse, Board of Commissioners Meeting Room, Second Floor, 153 Courthouse Road, Currituck, North Carolina 27929.

The Owner has set a verifiable goal of ten percent (10%) participation by Minority Business Participation for the construction contract. The Contractor shall comply with the State of North Carolina Historically Underutilized Program requirements in solicitation and preparation of their bid. Noncompliance with this program shall be grounds for declaring a bidder non-responsive.

A modified version of the bid form is attached to include the requirement of submission of HUB forms with the bid.

BID FORM

CURRITUCK FAMILY YMCA PARTIAL ROOF REPLACEMENT

The undersigned, as Bidder, hereby declares that the only person or persons interested in this bid as principal or principals is or are named herein and that no other person than herein mentioned has any interest in this Bid or in the contract to be entered into; that this Bid is made without connection with any other person, company or parties making a bid or proposal; and that it is in all respects fair and in good faith without collusion or fraud

The Bidder further declares that Bidder has examined the site of the Work and the Contract Documents relative thereto, and that Bidder as satisfied itself relative to the Work to be performed.

The Bidder proposes and agrees if this bid is accepted to contract with Currituck County, in the form of contract specified below, to furnish all necessary materials, equipment, machinery, tools, apparatus, means of transportation and labor necessary to complete the construction for which a bid is shown, in full accordance with the plans, specifications and contract documents, to the full and entire satisfaction of Currituck County with a definite understanding that no money will be allowed for extra work except as set forth in the General Conditions and the Contract Documents, for the sum as set forth hereinafter.

Bidders shall submit a bid on a lump sum basis for the Base Bid and include a separate price for each alternate described in the Contract Documents and as provided for in the Bid Form. The price for each alternate will be the amount added to the base bid if the Owner selects the alternate. **Refer to Section 01 23 00 Alternates in the Project Manual.**

Bidder shall also provide unit price bids. For each unit price item on the Bid Form, Bidder shall enter the unit price bid, and shall enter the computation of the respective quantity times the Bidder's unit price for that item. Discrepancies between the multiplication of quantity and unit prices will be resolved in favor of the unit prices. If the required quantities of the items listed in the unit price bid are increased or decreased by Change Order, the adjustment unit prices set forth in the bid shall apply to such increased or decreased quantities. Use the unit price submitted on the Bid Form to compute the quantity allowances. The quantities indicated on the Bid Form are estimated quantities only for the purpose of comparing bids. Compensation for the unit price bid made for the exact quantity of work performed under the unit price item. Deductive amounts of unit price work included in the Contract Sum are calculated at 100% of the quoted add unit price. Refer to Section 01 22 00 Unit Prices and Section 01 21 00 Allowances in the Project Manual.

In the comparison of bids, alternates and unit prices will be applied as listed in the Bid Form. The Bidder which maximizes the quantity of work and has the lowest bid within the budget will be the apparent low bidder.

The Bidder further proposes and agrees hereby to commence work under this Contract on a date to be specified in a written order by the Owner and shall fully complete all work thereunder within the time specified in the Agreement. Applicable liquidated damages amount is as stated in the Agreement.

The Bidder further agrees that in the case of failure on Bidder's part to execute the said contract and the bonds within ten (10) consecutive calendar days after being given written notice of the award of contract, the certified check, cash or bid bond accompanying this bid shall be paid into the funds of the Owner's account set aside for the project, as liquidated damages for such failure; otherwise the certified check, cash or bid bond accompanying this proposal shall be returned to the undersigned.

Examples of documentation that <u>may</u> be required to demonstrate the Bidder's good faith efforts to meet the goals set forth in these provisions include, but are not necessarily limited to, the following:

- A. Copies of solicitations for quotes to at least three (3) minority business firms from the source list provided by the State for each subcontract to be let under this contract (if 3 or more firms are shown on the source list). Each solicitation shall contain a specific description of the work to be subcontracted, location where bid documents can be reviewed, representative of the Prime Bidder to contact, and location, date and time when quotes must be received.
- B. Copies of quotes or responses received from each firm responding to the solicitation.
- C. A telephone log of follow-up calls to each firm sent a solicitation.
- D. For subcontracts where a minority business firm is not considered the lowest responsible sub-bidder, copies of quotes received from all firms submitting quotes for that particular subcontract.
- E. Documentation of any contacts or correspondence to minority business, community, or contractor organizations in an attempt to meet the goal.
- F. Copy of pre-bid roster
- G. Letter documenting efforts to provide assistance in obtaining required bonding or insurance for minority business.
- H. Letter detailing reasons for rejection of minority business due to lack of qualification.
- I. Letter documenting proposed assistance offered to minority business in need of equipment, loan capital, lines of credit, or joint pay agreements to secure loans, supplies, or letter of credit, including waiving credit that is ordinarily required.

Failure to provide the documentation as listed in these provisions may result in rejection of the bid and award to the next lowest responsible and responsive bidder.

Pursuant to GS143-128.2(d), the undersigned will enter into a formal agreement with Minority Firms for work listed in this schedule conditional upon execution of a contract with the Owner. Failure to fulfill this commitment may constitute a breach of the contract.
