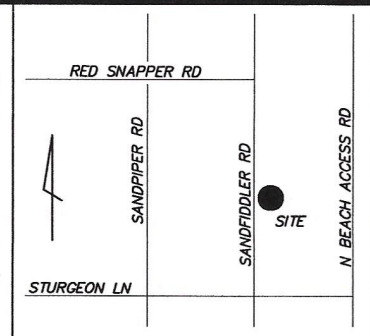

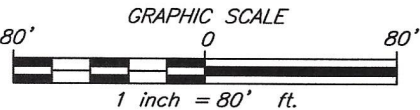
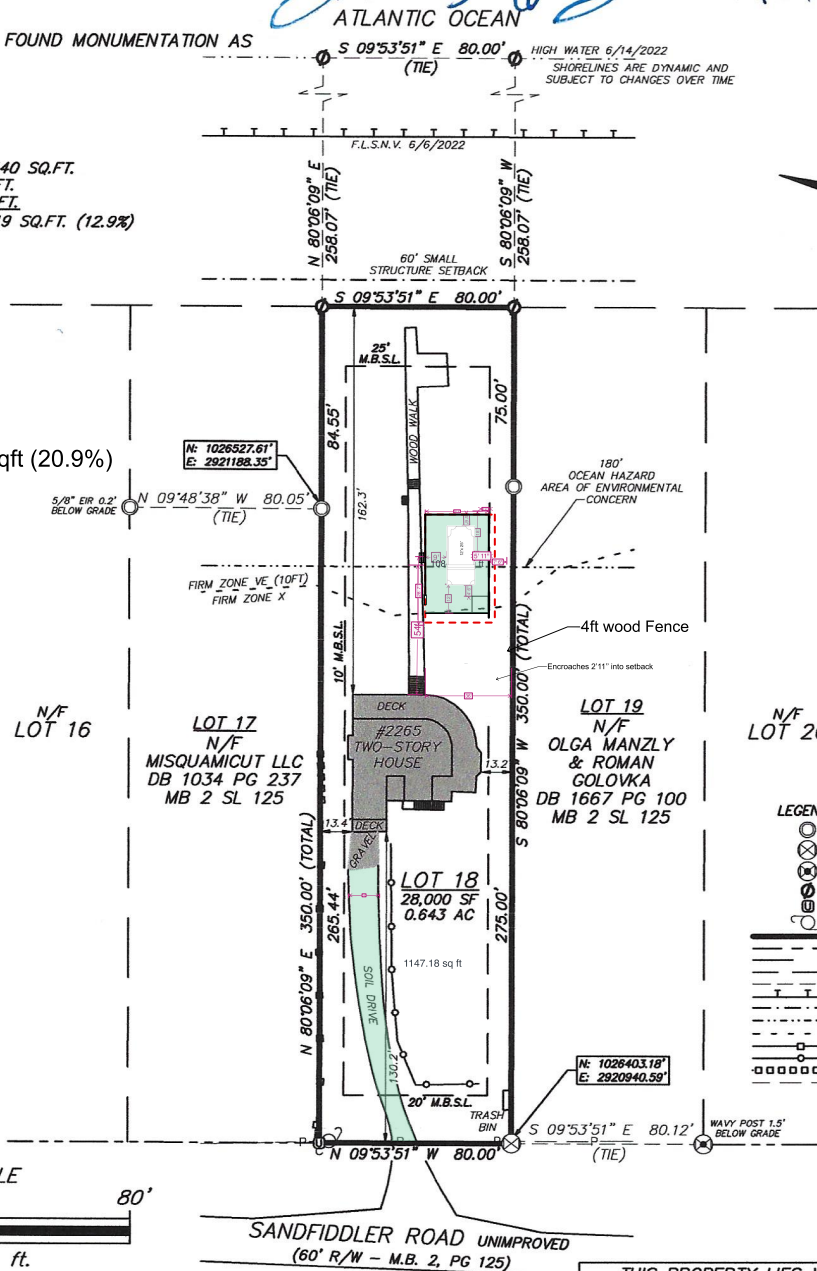
VICINITY MAP
